1	SECTION 1. CLARIFICATION OF ENTITLEMENT TO WAR-
2	TIME DISABILITY COMPENSATION FOR
3	WOMEN VETERANS WHO HAVE SERVICE-CON-
4	NECTED MASTECTOMIES.
5	(a) In General.—Section 1114(k) of title 38,
6	United States Code, is amended by inserting "of half or
7	more of the tissue" after "anatomical loss" the second
8	place it appears.
9	(b) Effective Date.—The amendment made by
10	subsection (a) shall take effect on the date of the enact-
11	ment of this Act, and shall apply with respect to months
12	that begin on or after that date.
13	SEC. 2. PERMANENT AUTHORITY FOR COUNSELING AND
14	TREATMENT FOR SEXUAL TRAUMA.

4	SEC. 3. REPORT ON FURNISHING OF HEALTH CARE TO
5	WOMEN VETERANS BY VETERANS HEALTH
6	ADMINISTRATION.
7	(a) REPORT REQUIRED.—Not later than 180 days
8	after the date of the enactment of this Act, the Secretary
9	of Veterans Affairs shall submit to the Committees or
10	Veterans' Affairs of the Senate and the House of Rep-
11	resentatives a report on the furnishing by the Veterans
12	Health Administration of health care for women veterans.
13	(b) REPORT ELEMENTS.—The report under sub-
14	section (a) shall set forth the following:
15	(1) A list of each Women Veterans' Comprehen-
16	sive Health Center within the Veterans Health Ad-
17	ministration, including whether such Center is lo-
18	cated in a Department of Veterans Affairs medical
19	center or outpatient clinic.
20	(2) For each Center listed under paragraph
21	(1)—
22	(A) the staffing level of such Center, ex-
23	pressed in terms of number of full-time equiva-
24	lent employees (FTEEs);

1	(B) the health care services furnished by
2	such Center to women veterans, including the
3	health care services (including breast cancer
4	screening and cervical cancer screening) that
5	are furnished only for women; and
6	(C) the number of women veterans fur-
7	nished health care services by such Center dur-
8	ing the last fiscal year ending before the date
9	of the report.
10	(3) A list of each facility without a Women Vet-
11	erans' Comprehensive Health Center that furnishes
12	health care services to women veterans through a
13	full-service womens' primary care team, including
14	whether such facility is located in a Department
15	medical center or outpatient clinic.
16	(4) For each facility listed under paragraph
17	(3)—
18	(A) the staffing level of such facility for
19	the furnishing of health care services to women
20	veterans, expressed in terms of number of full-
21	time equivalent employees (FTEEs);
22	(B) the health care services furnished by
23	such facility to women veterans, including the
24	health care services (including breast cancer

- screening and cervical cancer screening) that

 are furnished only for women; and
 - (C) the number of women veterans furnished health care services by such facility during the last fiscal year ending before the date of the report.
 - (5) For each Veterans Integrated Service Network and Department medical center, the number of hours per week that the Women Veterans' Coordinator of such network or medical center, as the case may be, is authorized to perform duties relating to the furnishing of health care services to women veterans.
