A BILL

To reliquidate certain entries of tomato sauce preparation.

Be it enacted by the Senate and House of Representa-1 tives of the United States of America in Congress assembled, 3 SECTION 1. RELIQUIDATION OF CERTAIN TOMATO SAUCE 4 PREPARATION ENTERED BETWEEN JUNE 17, 5 1991 AND OCTOBER 3, 1991. 6 (a) In General.—Notwithstanding section 514 of the Tariff Act of 1930 (19 U.S.C. 1514) or any other pro-8 vision of law and subject to the provisions of subsection (b), the United States Customs Service shall, not later than 90 days after the receipt of the request described 10

in subsection (b), liquidate or reliquidate each entry de-

scribed in subsection (d) containing any merchandise

- 1 which, at the time of the original liquidation, was classified
- 2 under subheading 2002.10.00 of the Harmonized Tariff
- 3 Schedule of the United States (relating to tomatoes, pre-
- 4 pared or preserved) at the rate of duty that would have
- 5 been applicable to such merchandise if the merchandise
- 6 had been liquidated or reliquidated under subheading
- 7 2103.90.60 of the Harmonized Tariff Schedule of the
- 8 United States (relating to tomato sauce preparation) on
- 9 the date of entry.
- 10 (b) Requests.—Reliquidation may be made under
- 11 subsection (a) with respect to an entry described in sub-
- 12 section (d) only if a request therefore is filed with the Cus-
- 13 toms Service within 90 days after the date of enactment
- 14 of this Act.
- 15 (c) Payment of Amounts Owed.—Any amounts
- 16 owed by the United States pursuant to the liquidation or
- 17 reliquidation of an entry under subsection (a), including
- 18 any interest provided for by law, shall be paid not later
- 19 than 90 days after the date of such liquidation or reliqui-
- 20 dation.
