A BILL

To amend title 38, United States Code, to make permanent the Native American veterans housing loan program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT AUTHORITY FOR NATIVE AMER-**
4 **ICAN VETERANS HOUSING LOAN PROGRAM.**

5 (a) PERMANENT AUTHORITY.—Section 3761 of title
6 38, United States Code, is amended by striking subsection
7 (c).

8 (b) REPORTING REQUIREMENTS.—Subsection (j) of
9 section 3762 of that title is amended—

1 (1) in the matter preceding paragraph (1), by
 2 striking “through 2002”; and

3 (2) by striking “pilot” each place it appears.

4 (c) CONFORMING AMENDMENTS.—(1) Section 3761
 5 of that title is further amended—

6 (A) in subsection (a)—

7 (i) in the first sentence, by striking “estab-
 8 lish and implement a pilot program” and insert-
 9 ing “carry out a program”; and

10 (ii) in the second sentence, by striking “es-
 11 tablish and implement the pilot program” and
 12 inserting “carry out the program”; and

13 (B) in subsection (b), by striking “pilot”.

14 (2) Section 3762 of that title is further amended—

15 (A) in subsection (b)(1)(E), by striking “pilot
 16 program established under this subchapter is imple-
 17 mented” and inserting “program under this sub-
 18 chapter is carried out”;

19 (B) in the second sentence of subsection
 20 (c)(1)(B), by striking “in order to carry out” and all
 21 that follows through “direct housing loans” and in-
 22 serting “to make direct housing loans under the pro-
 23 gram under this subchapter”; and

24 (C) in subsection (i)—

25 (i) in paragraph (1), by striking “pilot”;

1 (ii) in paragraph (2)(A)—

2 (I) by striking “pilot program” the
3 first place it appears and inserting “pro-
4 gram provided for under this subchapter”;
5 and

6 (II) by striking “pilot program” the
7 second place it appears and inserting “that
8 program”; and

9 (iii) in paragraph (2)(E), by striking “pilot
10 program” and inserting “program provided for
11 under this subchapter”.

12 (d) CLERICAL AMENDMENTS.—(1) The section head-
13 ing of section 3761 of that title is amended to read as
14 follows:

15 **“§ 3761. Housing loan program”.**

16 (2) The subchapter heading of subchapter V of chap-
17 ter 37 of that title is amended to read as follows:

18 **“SUBCHAPTER V—NATIVE AMERICAN VETERAN
19 HOUSING LOAN PROGRAM”.**

20 (3) The table of sections at the beginning of chapter
21 37 of that title is amended by striking the item relating
22 to subchapter V and the item relating to section 3761 and
23 inserting the following new items:

“SUBCHAPTER V—NATIVE AMERICAN VETERAN HOUSING LOAN
PROGRAM

“3761. Housing loan program.”.
