A BILL

To provide for the reliquidation of certain entries involving machines used to replicate optical discs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. RELIQUIDATION OF ENTRIES INVOLVING IM-
- 4 PORTATION OF REPLICATION MACHINES.
- 5 (a) In General.—Notwithstanding sections 514 and
- 6 520 of the Tariff Act of 1930 (19 U.S.C. 1514 and 1520)
- 7 or any other provision of law, the United States Customs
- 8 Service shall, not later than 90 days after the date of en-
- 9 actment of this Act, reliquidate, as duty free, the entries
- 10 identified in subsection (c).

- 1 (b) Payment of Amounts Owed.—Any amounts
- 2 owed by the United States pursuant to reliquidation of
- 3 an entry under subsection (a), plus lawful interest ac-
- 4 crued, shall be paid by the Customs Service within 90 days
- 5 after such reliquidation.
