A BILL

To provide for the liquidation or reliquidation of certain entries.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ENTRIES OF CERTAIN POSTERS.
- 4 (a) In General.—Notwithstanding section 514 of
- 5 the Tariff Act of 1930 (19 U.S.C. 1514) or any other pro-
- 6 vision of law and subject to the provisions of subsection
- 7 (b), the United States Customs Service shall, not later
- 8 than 90 days after the receipt of the request described
- 9 in subsection (b), liquidate or reliquidate each entry de-
- 10 scribed in subsection (d) containing any merchandise
- 11 which, at the time of the original liquidation, was classified

- 1 under subheading 4911.91.20 of the Harmonized Tariff
- 2 Schedule of the United States at the rate of duty that
- 3 would have been applicable to such merchandise if the
- 4 merchandise had been liquidated or reliquidated under
- 5 subheading 4911.91.40 of the Harmonized Tariff Sched-
- 6 ule of the United States on the date of entry.
- 7 (b) REQUESTS.—Reliquidation may be made under
- 8 subsection (a) with respect to an entry described in sub-
- 9 section (d) only if a request therefor is filed with the Cus-
- 10 toms Service within 90 days after the date of enactment
- 11 of this Act.
- 12 (c) Payment of Amounts Owed.—Any amounts
- 13 owed by the United States pursuant to the liquidation or
- 14 reliquidation of an entry under subsection (a) shall be paid
- 15 not later than 90 days after the date of such liquidation
- 16 or reliquidation.
