- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Auction Completion
- 5 Timing Act" hereinafter referred to as the "ACT NOW
- 6 Act".

1	SEC. 2. TIMING OF THE AUCTION OF SPECTRUM IN THE
2	747-762 MHZ AND 777-792 MHZ BANDS.
3	(a) Sections 213(a)(3) through (a)(6) of H.R. 3425,
4	the Miscellaneous Appropriations Act, 2000, as enacted by
5	section $1000(a)(5)$ of the Consolidated Appropriations
6	Act, $2000~(113~\mathrm{Stat.}~1501\mathrm{A-}295)$, shall remain in effect
7	through September 30, 2002.
8	(b) Section 213(a)(3) is further amended by—
9	(1) deleting "September 30, 2000" and insert-
10	ing "September 30, 2002"; and
11	(2) deleting "described in paragraph (2)" and
12	inserting "with respect to the portion of the spec-
13	trum identified in section 337(a)(2) of the Commu-
14	nications Act of 1934 (47 U.S.C. 337(a)(2))".
15	SEC. 3. FUTURE SPECTRUM ACTION DEADLINES.
16	The Communications Act of 1934 is amended by in-
17	serting a new paragraph (15) after section $309(j)(14)$, as
18	follows:
19	"(15) Federal Communications Commission to
20	determine spectrum auction schedule. Except as oth-
21	erwise provided in section 2 of the ACT NOW Act,
22	and in sections 309(j)(14)(C)(ii) of the Communica-
23	tions Act of 1934 and 3007 of the Balanced Budget
24	Act of 1997 (iii Stat. 269), (i) notwithstanding any
25	other statutory deadline for conducting spectrum
26	auctions, collecting, depositing, or reporting auction

revenues, completing licensing processing processes, or (ii) other provision of law, regulation, or policy to the contrary, the Commission may determine the date of any auction conducted pursuant to Section 5 309(j).".
