A BILL

To amend section 507 of the Omnibus Parks and Public Lands Management Act of 1996 to authorize additional appropriations for historically black colleges and universities, to decrease the cost-sharing requirement relating to the additional appropriations, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DECREASED MATCHING REQUIREMENT; AU-**
4 **THORIZATION OF APPROPRIATIONS.**

5 (a) DECREASED MATCHING REQUIREMENT.—Sec-
6 tion 507(c) of the Omnibus Parks and Public Lands Man-
7 agement Act of 1996 (16 U.S.C. 470a note) is amended—

1 (1) by striking “(1) Except” and inserting the
 2 following:

3 “(1) IN GENERAL.—Except”;

4 (2) by striking “paragraph (2)” and inserting
 5 “paragraphs (2) and (3)”;

6 (3) by striking “(2) The Secretary” and insert-
 7 ing the following:

8 “(2) WAIVER.—The Secretary”;

9 (4) by striking “paragraph (1)” and inserting
 10 “paragraphs (1) and (3)”;

11 (5) by adding at the end the following new
 12 paragraph:

13 “(3) EXCEPTION.—The Secretary may obligate
 14 funds made available under subsection (d)(2) for a
 15 grant with respect to a building or structure listed
 16 on, or eligible for listing on, the National Register
 17 of Historic Places only if the grantee agrees to pro-
 18 vide, from funds derived from non-Federal sources,
 19 an amount that is equal to 30 percent of the total
 20 cost of the project for which the grant is provided.”.

21 (b) AUTHORIZATION OF APPROPRIATION.—Section
 22 507(d) of the Omnibus Parks and Public Lands Manage-
 23 ment Act of 1996 (16 U.S.C. 470a note) is amended—

24 (1) by striking “Pursuant to” and inserting the
 25 following:

1 “(1) 1996 AUTHORIZATION.—Pursuant to”;
2 and

3 (2) by adding at the end the following new
4 paragraph:

5 “(2) ADDITIONAL AUTHORIZATION.—In addi-
6 tion to amounts made available under paragraph
7 (1), pursuant to section 108 of the National Historic
8 Preservation Act, there are authorized to be appro-
9 priated such sums as are necessary to carry out the
10 purposes of this section.”.
