## A BILL

To amend title 5, United States Code, to provide that the mandatory separation age for Federal firefighters be made the same as the age that applies with respect to Federal law enforcement officers.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Federal Firefighters  
3 Retirement Age Fairness Act”.

4 **SEC. 2. MANDATORY SEPARATION AGE FOR FIREFIGHTERS.**

5 (a) CIVIL SERVICE RETIREMENT SYSTEM.—

6 (1) IN GENERAL.—The second sentence of sec-  
7 tion 8335(b) of title 5, United States Code, is  
8 amended—

9 (A) by inserting “, firefighter,” after “law  
10 enforcement officer”; and

11 (B) by inserting “, firefighter,” after “that  
12 officer”.

13 (2) CONFORMING AMENDMENT.—Section  
14 8335(b) of title 5, United States Code, is amended  
15 by striking the first sentence.

16 (b) FEDERAL EMPLOYEES’ RETIREMENT SYSTEM.—

17 (1) IN GENERAL.—The second sentence of sec-  
18 tion 8425(b) of title 5, United States Code, is  
19 amended—

20 (A) by inserting “, firefighter, after “law  
21 enforcement officer” each place it appears; and

22 (B) by striking “courier” the second place  
23 it appears and inserting “courier, as the case  
24 may be.”.
