A BILL

To amend title 10, United States Code, to revise the age and service requirements for eligibility to receive retired pay for non-regular service.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ELIGIBILITY FOR RETIRED PAY FOR NON-REG-
- 4 ULAR SERVICE.
- 5 (a) AGE AND SERVICE REQUIREMENTS.—Subsection
- 6 (a) of section 12731 of title 10, United States Code, is
- 7 amended to read as follows:
- 8 "(a)(1) Except as provided in subsection (c), a person
- 9 is entitled, upon application, to retired pay computed
- 10 under section 12739 of this title, if the person—

1	"(A) satisfies one of the combinations of re-
2	quirements for minimum age and minimum number
3	of years of service (computed under section 12732 of
4	this title) that are specified in the table in para-
5	graph (2);
6	"(B) performed the last eight years of quali-
7	fying service while a member of any category named
8	in section 12732(a)(1) of this title, but not while a
9	member of a regular component, the Fleet Reserve,
10	or the Fleet Marine Corps Reserve; and
11	"(C) is not entitled, under any other provision

"(C) is not entitled, under any other provision of law, to retired pay from an armed force or retainer pay as a member of the Fleet Reserve or the Fleet Marine Corps Reserve.

"(2) The combinations of minimum age and minimum years of service required of a person under subparagraph (A) of paragraph (1) for entitlement to retired pay as provided in such paragraph are as follows:

19 (b) 20-YEAR LETTER.—Subsection (d) of such sec-20 tion is amended by striking "the years of service required 21 for eligibility for retired pay under this chapter" in the

- 1 first sentence and inserting "20 years of service computed
- 2 under section 12732 of this title.".
- 3 (c) Application to Existing Provisions of Law
- 4 OR POLICY.—With respect to any provision of law, or of
- 5 any policy, regulation, or directive of the executive branch,
- 6 that refers to a member or former member of the uni-
- 7 formed services as being eligible for, or entitled to, retired
- 8 pay under chapter 1223 of title 10, United States Code,
- 9 but for the fact that the member or former member is
- 10 under 60 years of age, such provision shall be carried out
- 11 with respect to that member or former member by sub-
- 12 stituting for the reference to that fact a reference to the
- 13 fact that the member or former member does not meet
- 14 the minimum age and service requirements of section
- 15 12731(a)(1)(A) of title 10, United States Code, as amend-
- 16 ed by subsection (a).
- 17 (d) Effective Date.—This section and the amend-
- 18 ments made by this subsection (a) shall take effect on the
- 19 first day of the first month beginning on or after the date
- 20 of the enactment of this Act and shall apply with respect
- 21 to retired pay payable for that month and subsequent
- 22 months.
