7 (a) AMENDMENT OF 1994 ACT.—The National Mari-

8 time Heritage Act of 1994 (16 U.S.C. 5401 et seq.) is

3	"SEC. 9A. DESIGNATION OF AMERICA'S NATIONAL MARI-
4	TIME MUSEUM.
5	"(a) In General.—America's National Maritime
6	Museum is comprised of those museums designated by law
7	to be museums of America's National Maritime Museum
8	on the basis that they—
9	"(1) house a collection of maritime artifacts
10	clearly representing the Nation's maritime heritage;
11	and
12	"(2) provide outreach programs to educate the
13	public about the Nation's maritime heritage.
14	"(b) Initial Designation of Museums.—The fol-
15	lowing museums (meeting the criteria specified in sub-
16	section (a)) are designated as museums of America's Na-
17	tional Maritime Museum:
18	"(1) The Mariners' Museum, located at 100
19	Museum Drive, Newport News, Virginia.
20	"(2) The South Street Seaport Museum, lo-
21	cated at 207 Front Street, New York, New York.
22	"(3) The Maine Maritime Museum, located at
23	243 Washington Street, Bath, Maine.
24	"(4) The Penobscot Marine Museum, located at
25	5 Church Street, Searsport, Maine.

2	Museum, located at 265 Massachusetts, Cambridge,

4	"(6) The New Bedford Whaling Museum, lo-

18	"(c) Future Designation of Other Museums
19	NOT PRECLUDED.—The designation of the museums re-
20	ferred to in subsection (b) as museums of America's Na-
21	tional Maritime Museum does not preclude the designation
22	by law of any other museum that meets the criteria speci-
23	fied in subsection (a) as a museum of America's National
24	Maritime Museum.

- 1 "(d) Reference to Museums.—Any reference in
- 2 any law, map, regulation, document, paper, or other
- 3 record of the United States to a museum designated by
- 4 law to be a museum of America's National Maritime Mu-
- 5 seum shall be deemed to be a reference to that museum
- 6 as a museum of America's National Maritime Museum.".
- 7 SEC. 2. REPEAL OF SUPERSEDED LAW.
- 8 Section 1068 of the Strom Thurmond National De-
- 9 fense Authorization Act for Fiscal Year 1999 (Public Law
- 10 105–261; 112 Stat. 2135; 16 U.S.C. 5409) is repealed.
