A BILL

To reauthorize the Federal Trade Commission for fiscal
years 2003, 2004, and 2005, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Federal Trade Com-
5 mission Reauthorization Act of 2002”.

1 **SEC. 2. REAUTHORIZATION.**

2 The text of section 25 of the Federal Trade Commis-
3 sion Act (15 U.S.C. 57c) is amended to read as follows:

4 “There are authorized to be appropriated to carry out
5 the functions, powers, and duties of the Commission not
6 to exceed \$179,271,000 for fiscal year 2003,
7 \$207,691,000 for fiscal year 2004, and \$224,493,000 for
8 fiscal year 2005.”.

9 **SEC. 3. COMMON CARRIERS REGULATED BY THE COMMU-
10 NICATIONS ACT OF 1934.**

11 Section 4 of the Federal Trade Commission Act (15
12 U.S.C. 44) is amended by striking the definition of the
13 term “Acts to regulate commerce” and inserting the fol-
14 lowing:

15 “‘Acts to regulate commerce’ means subtitle IV of
16 title 49, United States Code, and all Acts amendatory
17 thereof and supplementary thereto.”.

18 **SEC. 4. AUTHORITY TO ACCEPT REIMBURSEMENTS, GIFTS,
19 AND VOLUNTARY AND UNCOMPENSATED
20 SERVICES.**

21 The Federal Trade Commission Act (15 U.S.C. 41
22 et seq.) is amended—

23 (1) by redesignating section 26 as section 28;

24 and

25 (2) by inserting after section 25 the following:

1 **“SEC. 26. REIMBURSEMENT OF EXPENSES.**

2 “The Commission may accept payment or reimburse-
 3 ment, in cash or in kind, from a domestic or foreign law
 4 enforcement authority, or payment or reimbursement
 5 made on behalf of such authority, for expenses incurred
 6 by the Commission, its members, or employees in carrying
 7 out any activity pursuant to a statute administered by the
 8 Commission without regard to any other provision of law.
 9 Any such payments or reimbursements shall be considered
 10 a reimbursement to the appropriated funds of the Com-
 11 mission.

12 **“SEC. 27. GIFTS AND VOLUNTARY AND UNCOMPENSATED**
 13 **SERVICES.**

14 “(a) IN GENERAL.—In furtherance of its functions
 15 the Commission may accept, hold, administer, and use un-
 16 conditional gifts, donations, and bequests of real, personal,
 17 and other property and, notwithstanding section 1342 of
 18 title 31, United States Code, accept voluntary and uncom-
 19 pensated services.

20 “(b) LIMITATIONS.—

21 “(1) CONFLICTS OF INTEREST.—
 22 Notwithstanding subsection (a), the Commission
 23 may not accept, hold, administer, or use a gift, do-
 24 nation, or bequest if the acceptance, holding, admin-
 25 istration, or use would create a conflict of interest
 26 or the appearance of a conflict of interest.

1 “(2) VOLUNTARY SERVICES.—A person who
2 provides voluntary and uncompensated service under
3 subsection (a) shall not be considered a Federal em-
4 ployee for any purpose other than for purposes of
5 chapter 81 of title 5, United States Code, (relating
6 to compensation for injury) and section 2671
7 through 2680 of title 28, United States Code,
8 (relating to tort claims).”.
