Mr. Nelson of Nebraska introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To provide emergency disaster assistance to agricultural producers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Emergency Agricul-
- 5 tural Disaster Assistance Act of 2002".
- 6 SEC. 2. CROP DISASTER ASSISTANCE.
- 7 (a) In General.—The Secretary of Agriculture
- 8 (referred to in this Act as the "Secretary") shall use such
- 9 sums as are necessary of funds of the Commodity Credit
- 10 Corporation to make emergency financial assistance au-
- 11 thorized under this section available to producers on a

- 1 farm that have incurred qualifying crop losses for the
- 2 2001 or 2002 crop, or both, due to damaging weather or
- 3 related condition, as determined by the Secretary.
- 4 (b) Administration.—The Secretary shall make as-
- 5 sistance available under this section in the same manner
- 6 as provided under section 815 of the Agriculture, Rural
- 7 Development, Food and Drug Administration, and Re-
- 8 lated Agencies Appropriations Act, 2001 (Public Law
- 9 106–387; 114 Stat. 1549A–55), including using the same
- 10 loss thresholds for the quantity and quality losses as were
- 11 used in administering that section.
- 12 (c) Crop Insurance.—In carrying out this section,
- 13 the Secretary shall not discriminate against or penalize
- 14 producers on a farm that have purchased crop insurance
- 15 under the Federal Crop Insurance Act (7 U.S.C. 1501 et
- 16 seq.).

17 SEC. 3. LIVESTOCK ASSISTANCE PROGRAM.

- 18 (a) In General.—The Secretary shall use such
- 19 sums as are necessary of funds of the Commodity Credit
- 20 Corporation as are necessary to make and administer pay-
- 21 ments for livestock losses to producers for 2001 or 2002
- 22 losses, or both, in a county that has received a cor-
- 23 responding emergency designation by the President or the
- 24 Secretary, of which an amount determined by the Sec-
- 25 retary shall be made available for the American Indian

- 1 livestock program under section 806 of the Agriculture,
- 2 Rural Development, Food and Drug Administration, and
- 3 Related Agencies Appropriations Act, 2001 (Public Law
- 4 106–387; 114 Stat. 1549A–51).
- 5 (b) ADMINISTRATION.—The Secretary shall make as-
- 6 sistance available under this section in the same manner
- 7 as provided under section 806 of the Agriculture, Rural
- 8 Development, Food and Drug Administration, and Re-
- 9 lated Agencies Appropriations Act, 2001 (Public Law
- 10 106–387; 114 Stat. 1549A–51).
- 11 SEC. 4. FUNDING.
- Of the funds of the Commodity Credit Corporation,
- 13 the Secretary shall—
- 14 (1) use such sums as are necessary to carry out
- this Act; and
- 16 (2) transfer to section 32 of the Act of August
- 17 24, 1935 (7 U.S.C. 612c), an amount equal to the
- amount of funds under section 32 of that Act that
- were made available before the date of enactment of
- 20 this Act to provide disaster assistance to crop and
- 21 livestock producers for losses suffered during 2001
- and 2002, to remain available until expended.
- 23 SEC. 5. REGULATIONS.
- 24 (a) In General.—The Secretary may promulgate
- 25 such regulations as are necessary to implement this Act.

- 1 (b) Procedure.—The promulgation of the regula-
- 2 tions and administration of this Act shall be made without
- 3 regard to—
- 4 (1) the notice and comment provisions of sec-
- 5 tion 553 of title 5, United States Code;
- 6 (2) the Statement of Policy of the Secretary of
- 7 Agriculture effective July 24, 1971 (36 Fed. Reg.
- 8 13804), relating to notices of proposed rulemaking
- 9 and public participation in rulemaking; and
- 10 (3) chapter 35 of title 44, United States Code
- 11 (commonly known as the "Paperwork Reduction
- 12 Act'').
- 13 (c) Congressional Review of Agency Rule-
- 14 Making.—In carrying out this section, the Sec-
- 15 RETARY SHALL USE THE AUTHORITY PROVIDED UNDER
- 16 SECTION 808 OF TITLE 5, UNITED STATES CODE.
- 17 SEC. 6. EMERGENCY DESIGNATION.
- 18 (a) IN GENERAL.—The entire amount made available
- 19 under this Act shall be available only to the extent that
- 20 the President submits to Congress an official budget re-
- 21 quest for a specific dollar amount that includes designa-
- 22 tion of the entire amount of the request as an emergency
- 23 requirement for the purposes of the Balanced Budget and
- 24 Emergency Deficit Control Act of 1985 (2 U.S.C. 900 et
- 25 seq.).

- 1 (b) Designation.—The entire amount made
- 2 avialable under this section is designated by Congress as
- 3 an emergency requirement under sections 251(b)(2)(A)
- 4 and 252(e) of the Act (2 U.S.C. 901(b)(2)(A), 902(e)).

5 SEC. 7. BUDGETARY TREATMENT.

- 6 Notwithstanding Rule 3 of the Budget Scorekeeping
- 7 Guidelines set forth in the Joint Explanatory Statement
- 8 of the Committee of Conference accompanying Conference
- 9 Report No. 105–217, the provisions of this Act that would
- 10 have been estimated by the Office of Management and
- 11 Budget as changing direct spending or receipts under sec-
- 12 tion 252 of the Balanced Budget and Emergency Deficit
- 13 Control Act of 1985 (2 U.S.C. 902) were it included in
- 14 an Act other than an appropriation Act shall be treated
- 15 as direct spending or receipts legislation, as appropriate,
- 16 under section 252 of the Balanced Budget and Emergency
- 17 Deficit Control Act of 1985 (2 U.S.C. 902).
