Mr. INOUE introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To amend title XIX of the Social Security Act to provide for coverage of services provided by nursing school clinics under State Medicaid programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. MEDICAID COVERAGE OF SERVICES PROVIDED**

4 **BY NURSING SCHOOL CLINICS.**

5 (a) IN GENERAL.—Section 1905(a) of the Social Se-
6 curity Act (42 U.S.C. 1396d(a)) is amended—

7 (1) in paragraph (26), by striking “and” at the
8 end;

9 (2) by redesignating paragraph (27) as para-
10 graph (28); and

1 (3) by inserting after paragraph (26), the fol-
 2 lowing new paragraph:

3 “(27) nursing school clinic services (as defined
 4 in subsection (x)) furnished by or under the super-
 5 vision of a nurse practitioner or a clinical nurse spe-
 6 cialist (as defined in section 1861(aa)(5)), whether
 7 or not the nurse practitioner or clinical nurse spe-
 8 cialist is under the supervision of, or associated with,
 9 a physician or other health care provider; and”.

10 (b) NURSING SCHOOL CLINIC SERVICES DEFINED.—
 11 Section 1905 of the Social Security Act (42 U.S.C. 1396d)
 12 is amended by adding at the end the following new sub-
 13 section:

14 “(x) The term ‘nursing school clinic services’ means
 15 services provided by a health care facility operated by an
 16 accredited school of nursing which provides primary care,
 17 long-term care, mental health counseling, home health
 18 counseling, home health care, or other health care services
 19 which are within the scope of practice of a registered
 20 nurse.”.

21 (c) CONFORMING AMENDMENT.—Section
 22 1902(a)(10)(C)(iv) of the Social Security Act (42 U.S.C.
 23 1396a(a)(10)(C)(iv)) is amended by inserting “and (27)”
 24 after “(24)”.

1 (d) EFFECTIVE DATE.—The amendments made by
2 this section shall be effective with respect to payments
3 made under a State plan under title XIX of the Social
4 Security Act (42 U.S.C. 1396 et seq.) for calendar quar-
5 ters commencing with the first calendar quarter beginning
6 after the date of enactment of this Act.
