A BILL

To require individuals who lobby the President on pardon issues to register under the Lobbying Disclosure Act of 1995 and to require the President to report any gifts, pledges, or commitments of a gift to a trust fund established for purposes of establishing a Presidential library for that President after his or her term has expired.

2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DISCLOSURE OF LOBBYING ACTIVITIES WITH**
2 **RESPECT TO PRESIDENTIAL PARDONS.**

3 Section 3(8) of the Lobbying Disclosure Act of 1995

4 (2 U.S.C. 1602(8)) is amended—

5 (1) in subparagraph (A)—

6 (A) in clause (iii), by striking “or” after
7 the semicolon;

8 (B) in clause (iv), by striking the period
9 and inserting “; or”; and

10 (C) by adding at the end the following:

11 “(v) the issuance of a grant of execu-
12 tive clemency in the form of a pardon,
13 commutation of sentence, reprieve, or re-
14 mission of fine.”; and

15 (2) in subparagraph (B)(xii), by striking “made
16 to” and inserting “except as provided in subpara-
17 graph (A)(v), made to”.

18 **SEC. 2. AMENDMENT TO THE ETHICS IN GOVERNMENT ACT**
19 **OF 1978.**

20 Section 102(a) of the Ethics in Government Act of
21 1978 (5 U.S.C. App.) is amended by adding at the end
22 the following:

23 “(9) If the reporting individual is the President
24 and is currently serving as the President, the iden-
25 tity of the source, a brief description, and the value
26 of all gifts, pledges, or commitments of a gift aggre-

1 gating \$5000 or more for the establishment of a
2 Presidential library for that President after his or
3 her term has expired received from any source other
4 than a relative of the President during the preceding
5 calendar year. Information required to be reported
6 under this paragraph shall be made publicly avail-
7 able in accordance with this Act.”.
