A BILL

To amend the Fair Labor Standards Act of 1938 to provide for an increase in the Federal minimum wage.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fair Minimum Wage
- 5 Act of 2001".

1 SEC. 2. MINIMUM WAGE.

- 2 (a) IN GENERAL.—Section 6(a)(1) of the Fair Labor
- 3 Standards Act of 1938 (29 U.S.C. 206(a)(1)) is amended
- 4 to read as follows:
- 5 "(1) except as otherwise provided in this sec-
- 6 tion, not less than—
- 7 "(A) \$5.75 an hour beginning 30 days
- 8 after the date of enactment of the Fair Min-
- 9 imum Wage Act of 2001;
- 10 "(B) \$6.25 an hour during the year begin-
- 11 ning January 1, 2002; and
- 12 "(C) \$6.65 an hour beginning January 1,
- 13 2003;".
- 14 (b) Effective Date.—The amendment made by
- 15 subsection (a) shall take effect 30 days after the date of
- 16 enactment of this Act.
- 17 SEC. 3. APPLICABILITY OF MINIMUM WAGE TO THE COM-
- 18 MONWEALTH OF THE NORTHERN MARIANA
- 19 ISLANDS.
- 20 (a) IN GENERAL.—Section 6 of the Fair Labor
- 21 Standards Act of 1938 (29 U.S.C. 206) shall apply to the
- 22 Commonwealth of the Northern Mariana Islands.
- 23 (b) Transition.—Notwithstanding subsection (a),
- 24 the minimum wage applicable to the Commonwealth of the
- 25 Northern Mariana Islands under section 6(a)(1) of the

- 1 Fair Labor Standards Act of 1938 (29 U.S.C. 206(a)(1))
- 2 shall be—
- 3 (1) \$3.55 an hour beginning 30 days after the 4 date of enactment of this Act; and
- 5 (2) increased by \$0.50 an hour (or such lesser 6 amount as may be necessary to equal the minimum 7 wage under section 6(a)(1) of such Act), beginning 8 6 months after the date of enactment of this Act 9 and every 6 months thereafter until the minimum wage applicable to the Commonwealth of the North-10 ern Mariana Islands under this subsection is equal 11 12 to the minimum wage set forth in such section.
