Mr. Lugar, from the Committee on Agriculture, Nutrition, and Forestry, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Committee on Agriculture, Nutrition, and Forestry.

- 1 Resolved, That, in carrying out its powers, duties, and
- 2 functions under the Standing Rules of the Senate, in ac-
- 3 cordance with its jurisdiction under rule XXV of such
- 4 rules, including holding hearings, reporting such hearings,
- 5 and making investigations as authorized by paragraphs 1
- 6 and 8 of rule XXVI of the Standing Rules of the Senate,
- 7 the Committee on Agriculture, Nutrition, and Forestry is
- 8 authorized from March 1, 2001, through September 30,
- 9 2001; October 1, 2001 to September 30, 2002; and Octo-
- 10 ber 1, 2002 through February 28, 2003, in its discretion

- 1 (1) to make expenditures from the contingent fund of the
- 2 Senate, (2) to employ personnel, and (3) with the prior
- 3 consent of the Government department or agency con-
- 4 cerned and the Committee on Rules and Administration,
- 5 to use on a reimbursable or non-reimbursable basis the
- 6 services of personnel of any such department or agency.
- 7 Sec. 2. (a) The expenses of the committee for the
- 8 period March 1, 2001, through September 30, 2001,
- 9 under this resolution shall not exceed \$1,794,378, of
- 10 which amount (1) not to exceed \$20,000 may be expended
- 11 for the procurement of the services of individual consult-
- 12 ants, or organizations thereof (as authorized by section
- 13 202(i) of the Legislative Reorganization Act of 1946, as
- 14 amended), and (2) not to exceed \$4,000 may be expended
- 15 for the training of the professional staff of such committee
- 16 (under procedures specified by section 202(j) of the Legis-
- 17 lative Reorganization Act of 1946).
- 18 (b) The expenses of the committee for the period Oc-
- 19 tober 1, 2001, through September 30, 2002, under this
- 20 resolution shall not exceed \$3,181,922, of which amount
- 21 (1) not to exceed \$20,000 may be expended for the pro-
- 22 curement of the services of individual consultants, or orga-
- 23 nizations thereof (as authorized by section 202(i) of the
- 24 Legislative Reorganization Act of 1946, as amended), and
- 25 (2) not to exceed \$4,000 may be expended for the training

- 1 of the professional staff of such committee (under proce-
- 2 dures specified by section 202(j) of the Legislative Reorga-
- 3 nization Act of 1946).
- 4 (c) The expenses of the committee for the period Oc-
- 5 tober 1, 2002, through February 28, 2003, under this res-
- 6 olution shall not exceed \$1,360,530, of which amount (1)
- 7 not to exceed \$20,000 may be expended for the procure-
- 8 ment of the services of individual consultants, or organiza-
- 9 tions thereof (as authorized by section 202(i) of the Legis-
- 10 lative Reorganization Act of 1946, as amended), and (2)
- 11 not to exceed \$4,000 may be expended for the training
- 12 of the professional staff of such committee (under proce-
- 13 dures specified by section 202(j) of the Legislative Reorga-
- 14 nization Act of 1946).
- 15 Sec. 3. The committee shall report its findings, to-
- 16 gether with such recommendations for legislation as it
- 17 deems advisable, to the Senate at the earliest practicable
- 18 date, but not later than February 28, 2003, respectively.
- 19 Sec. 4. Expenses of the committee under this resolu-
- 20 tion shall be paid from the contingent fund of the Senate
- 21 upon vouchers approved by the chairman of the com-
- 22 mittee, except that vouchers shall not be required (1) for
- 23 the disbursement of salaries of employees paid at an an-
- 24 nual rate, or (2) for the payment of telecommunications
- 25 provided by the Office of the Sergeant at Arms and Door-

- 1 keeper, United States Senate, or (3) for the payment of
- 2 stationery supplies purchased through the Keeper of the
- 3 Stationery, United States Senate, or (4) for payments to
- 4 the Postmaster, United States Senate, or (5) for the pay-
- 5 ment of metered charges on copying equipment provided
- 6 by the Office of the Sergeant at Arms and Doorkeeper,
- 7 United States Senate, or (6) for the payment of Senate
- 8 Recording and Photographic Services, or (7) for payment
- 9 of franked and mass mail costs by the Sergeant at Arms
- 10 and Doorkeeper, United States Senate.
- 11 Sec. 5. There are authorized such sums as may be
- 12 necessary for agency contributions related to the com-
- 13 pensation of employees of the committee from March 1,
- 14 2001, through September 30, 2001; October 1, 2001,
- 15 through September 30, 2002; and October 1, 2002
- 16 through February 28, 2003 to be paid from the Appro-
- 17 priations account for "Expenses of Inquiries and Inves-
- 18 tigations".
