CONCURRENT RESOLUTION

- Expressing the need for enhanced public awareness of Traumatic Brain Injury and support for the designation of a National Brain Injury Awareness Month.
- Whereas Traumatic Brain Injury is the leading cause of death and disability among children and young adults in the United States;
- Whereas at least 5.3 million Americans currently live with permanent disabilities resulting from a Traumatic Brain Injury;
- Whereas at least 1.5 million Americans sustain a Traumatic Brain Injury each year;

- Whereas, each year, another 80,000 Americans sustain lifelong disabilities from a Traumatic Brain Injury, resulting in a life-altering experience that can include the most serious physical, cognitive, and emotional impairments;
- Whereas every 21 seconds, one person in the United States sustains a Traumatic Brain Injury;
- Whereas Traumatic Brain Injuries cost the nation \$48.3 billion annually, consisting of \$31.7 billion for hospitalization expenditures and \$16.6 billion for fatal brain injury expenditures;
- Whereas the lack of public awareness is so vast that Traumatic Brain Injury is known in the disability community as the Nation's "silent epidemic";
- Whereas the designation of a National Brain Injury Awareness Month will work towards enhancing the public awareness of Traumatic Brain Injury;
- Whereas former President Ronald Reagan proclaimed the month of October 1984 as National Head Injury Awareness Month; and
- Whereas the Brain Injury Association of America has recognized October as Brain Injury Awareness Month since 1980: Now, therefore, be it
