## A BILL

To amend title XVIII of the Social Security Act to exclude brachytherapy devices from the prospective payment system for outpatient hospital services under the Medicare Program.

1	SECTION 1. SPECIAL PAYMENT FOR BRACHYTHERAPY
2	UNDER OPD PPS.
3	(a) In General.—Section 1833(t)(13) of the Social
4	Security Act (42 U.S.C. 1395l(t)(13) is amended by add-
5	ing at the end the following new subparagraph:
6	"(B) Payment for devices of
7	BRACHYTHERAPY AT CHARGES ADJUSTED TO
8	COST.—
9	"(i) In General.—Notwithstanding
10	the preceding provisions of this subsection,
11	for a device of brachytherapy furnished on
12	or after the effective date described in
13	clause (ii), the amount of payment for the
14	device under this subsection is equal to the
15	hospital's charges for each device fur-
16	nished, adjusted to cost.
17	"(ii) Effective date.—The effective
18	date referred to in clause (i) is that date
19	that is the first day of the third month
20	that begins after the date of the enactment
21	of this subparagraph.".
22	(b) Specification of Groups for
23	Brachytherapy Devices.—Section 1833(t)(2) of such
24	Act (42 U.S.C. 1395l(t)(2) is amended—
25	(1) in subparagraph (F), by striking "and" at
26	the end;

- 1 (2) in subparagraph (G), by striking the period 2 at the end and inserting "; and"; and
  - (3) by adding at the end the following new subparagraph:

"(H) with respect devices of to brachytherapy furnished on or after the effective date described in paragraph (13)(B)(ii), the Secretary shall create additional groups of covered OPD services that classify such devices separately from the other services (or group of services) paid for under this subsection in a manner reflecting the number, isotope, and radioactive intensity of such devices furnished, including separate groups for palladium-103 and iodine-125 devices.".
