A BILL

To provide for a period of quiet reflection at the opening of certain schools on every school day.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 **SECTION 1. SHORT TITLE.**
- 4 This Act may be cited as the "Moment of Quiet Re-
- 5 flection in Schools Act".
- 6 SEC. 2. FINDINGS.
- 7 The Congress finds the following:

- 1 (1) In today's hectic society, all too few of the 2 Nation's citizens are able to experience even a mo-3 ment of quiet reflection before plunging headlong 4 into the day's activities.
- 5 (2) The Nation's young citizens are particularly 6 affected by this absence of an opportunity for a mo-7 ment of quiet reflection.
- 8 (3) The Nation's youth, and society as a whole, 9 would be well served if students were afforded a mo-10 ment of quiet reflection at the beginning of each day 11 in the public schools.

12 SEC. 3. MOMENT OF QUIET REFLECTION.

- 13 The Elementary and Secondary Education Act of
- 14 1965 (20 U.S.C. 6301 et seq.) is amended by inserting
- 15 after section 9536 the following:

16 "SEC. 9537. MOMENT OF QUIET REFLECTION.

- 17 "(a) In General.—Each local educational agency
- 18 receiving funds under this Act shall ensure that, at the
- 19 opening of school on every school day, the teacher in
- 20 charge of each classroom in each school served by the
- 21 agency conducts a brief period of quiet reflection for not
- 22 more than 60 seconds with the participation of all the stu-
- 23 dents assembled in the classroom.
- 24 "(b) CONDUCT.—A period of quiet reflection under
- 25 this section shall not be conducted as a religious service

- 1 or exercise, but shall be considered as an opportunity for
- 2 a moment of silent reflection on the anticipated activities
- 3 of the day.
- 4 "(c) Construction.—This section shall not be con-
- 5 strued as prohibiting or restricting constitutionally pro-
- 6 tected prayer.
- 7 "(d) Certification.—As a condition of receiving
- 8 funds under this Act, a local educational agency shall cer-
- 9 tify in writing to the State involved that the agency is in
- 10 compliance with this section.".
