### A BILL

To require the construction at Arlington National Cemetery of a memorial to the crew of the Columbia Orbiter.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Columbia Orbiter Me-
- 5 morial Act".
- 6 SEC. 2. CONSTRUCTION OF MEMORIAL TO CREW OF CO-
- 7 LUMBIA ORBITER AT ARLINGTON NATIONAL
- 8 CEMETERY.
- 9 (a) Construction Required.—The Secretary of
- 10 the Army shall, in consultation with the Administrator of
- 11 the National Aeronautics and Space Administration, con-
- 12 struct at an appropriate place in Arlington National Cem-
- 13 etery, Virginia, a memorial marker honoring the seven
- 14 members of the crew of the Columbia Orbiter who died
- 15 on February 1, 2003, over the State of Texas during the
- 16 landing of space shuttle mission STS-107.
- 17 (b) AVAILABILITY OF FUNDS.—Of the amount appro-
- 18 priated or otherwise made available by title II of the De-
- 19 partment of Defense Appropriations Act, 2003 (Public
- 20 Law 107–248) under the heading "Operation and
- 21 Maintenance, Army", \$500,000 shall be available for

- 1 the construction of the memorial marker required by sub-
- 2 section (a).
- 3 SEC. 3. DONATIONS FOR MEMORIAL FOR CREW OF COLUM-
- 4 BIA ORBITER.
- 5 (a) AUTHORITY TO ACCEPT DONATIONS.—The Ad-
- 6 ministrator of the National Aeronautics and Space Admin-
- 7 istration may accept gifts and donations of services,
- 8 money, and property (including personal, tangible, or in-
- 9 tangible property) for the purpose of an appropriate me-
- 10 morial or monument to the seven members of the crew
- 11 of the Columbia Orbiter who died on February 1, 2003,
- 12 over the State of Texas during the landing of space shuttle
- 13 mission STS-107, whether such memorial or monument
- 14 is constructed by the Administrator or is the memorial
- 15 marker required by section 2.
- 16 (b) Transfer.—(1) The Administrator may transfer
- 17 to the Secretary of the Army any services, money, or prop-
- 18 erty accepted by the Administrator under subsection (a)
- 19 for the purpose of the construction of the memorial mark-
- 20 er required by section 2.
- 21 (2) Any moneys transferred to the Secretary under
- 22 paragraph (1) shall be merged with amounts in the ac-
- 23 count referred to in subsection (b) of section 2, and shall
- 24 be available for the purpose referred to in that subsection.

- 1 (c) Expiration of Authority.—The authority of
- 2 the Administrator to accept gifts and donations under
- 3 subsection (a) shall expire five years after the date of the
- 4 enactment of this Act.
