A BILL

To direct the Secretary of the Interior to conduct a special resource study to determine the national significance of the Miami Circle site in the State of Florida as well as the suitability and feasibility of its inclusion in the National Park System as part of Biscayne National Park, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SPECIAL RESOURCE STUDY.

2	(a) STUDY.—Not later than 3 years after the date
3	funds are made available for this section, the Secretary
4	of the Interior (hereinafter referred to as the "Secretary")
5	shall conduct a special resource study to determine the
6	national significance of the Miami Circle archeological site
7	in Miami-Dade County, Florida (hereinafter referred to as
8	"Miami Circle"), as well as the suitability and feasibility
9	of its inclusion in the National Park System as part of
10	Biscayne National Park. In conducting the study, the Sec-
11	retary shall consult with the appropriate American Indian
12	tribes and other interested groups and organizations.
13	(b) Content of Study.—In addition to deter-
14	mining national significance, feasibility, and suitability,
15	the study shall include the analysis and recommendations
16	of the Secretary on—
17	(1) any areas in or surrounding the Miami Cir-
18	cle that should be included in Biscayne National
19	Park;
20	(2) whether additional staff, facilities, or other
21	resources would be necessary to administer the
22	Miami Circle as a unit of Biscayne National Park;
23	and
24	(3) any effect on the local area from the inclu-
25	sion of Miami Circle in Biscayne National Park.

- 1 (c) Submission of Report.—Not later than 30
- 2 days after completion of the study, the Secretary shall
- 3 submit a report on the findings and recommendations of
- 4 the study to the Committee on Energy and Natural Re-
- 5 sources of the Senate and the Committee on Resources
- 6 of the United States House of Representatives.
- 7 (d) Authorization of Appropriations.—There
- 8 are authorized to be appropriated such sums as are nec-
- 9 essary to carry out this section.
