## A BILL

To establish a pilot program to encourage certification of teachers in low-income, low-performing public elementary and secondary schools by the National Board for Professional Teaching Standards, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Board-Cer-
- 5 tified Teachers in Low-Performing Schools Act of 2003".

| 4  | (a) Program Authorized.—The Secretary of Edu-              |
| 5  | cation shall establish a 5-year pilot program under which  |
| 6  | Board-certified teachers in low-income, low-performing     |
| 7  | schools receive stipends under this section. The Secretary |
| 8  | may provide stipends for up to 100 teachers annually       |
| 9  | under this section. The Secretary shall seek the coopera-  |
| 10 | tion and assistance of the National Board for Professional |
| 11 | Teaching Standards in carrying out this section.           |
| 12 | (b) Annual Base Stipend Requirements.—A                    |
| 13 | Board-certified teacher shall receive an annual base sti-  |
| 14 | pend of \$5,000 under this section, for up to 4 years, if  |
| 15 | for each year the teacher receives a stipend, the teacher— |
| 16 | (1) is employed in a school that is a low-income,          |
| 17 | low-performing school in the first year the teacher        |
| 18 | receives the stipend;                                      |
| 19 | (2) acts as the resident facilitator for the               |
| 20 | school, including by—                                      |
| 21 | (A) conducting outreach among teachers                     |
| 22 | who may seek to become, or are in the process              |
| 23 | of becoming, Board-certified (including by hold-           |
| 24 | ing a minimum number of events or contacts                 |
| 25 | within the faculty of the school): and                     |

- 1 (B) facilitating participation in a support 2 program for teachers who are in the process of 3 becoming Board-certified; and
- 4 (3) serves as a liaison with the National Board 5 for Professional Teaching Standards, to recommend 6 ways to encourage teachers to aspire to receive 7 Board certification.
- 8 (c) Bonus Stipends.—A recipient of an annual base 9 stipend under subsection (b) may receive a bonus stipend 10 of \$1,000 for each teacher who completes the process for 11 becoming Board-certified at the school for which the re- 12 cipient is the resident facilitator (even though such teacher 13 may not necessarily become Board-certified at the comple- 14 tion of such process).
- 15 (d) Report to Congress.—The Secretary of Education shall submit to the Congress not earlier than the 16 end of the fourth year, nor later than the end of the pilot 17 program under this section, a report on the effectiveness 18 19 of the program in increasing the number of Board-certified teachers in the low-income, low-performing schools 20 21 in which the program's stipend recipients teach, including 22 any appropriate findings or recommendations.

| 15 | (3) The terms "elementary school", "secondary        |
| 16 | school", and "local educational agency" have the     |
| 17 | meanings given those terms in section 9101 of the    |
| 18 | Elementary and Secondary Education Act of 1965       |
| 19 | (20 U.S.C. 7801).                                    |
