## A BILL

To require the Administrator of the United States Agency for International Development and the Secretary of Defense to give a preference for American companies in the award of contracts to provide assistance for Iraq, and to require the use of CDMA technology in any such contract for the provision of commercial mobile wireless communication service.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1   **SECTION 1. PREFERENCE FOR AMERICAN COMPANIES IN**  
2                   **THE AWARD OF CONTRACTS FOR ASSIST-**  
3                   **ANCE FOR IRAQ.**

4       In entering into contracts with private entities to pro-  
5   vide assistance for Iraq, the Administrator of the United  
6   States Agency for International Development and the Sec-  
7   retary of Defense shall give preference, to the greatest ex-  
8   tent practicable, to qualified American entities. Contracts  
9   for which this preference shall be given shall include con-  
10   tracts to carry out commercial mobile wireless communica-  
11   tion service for Iraq.

12   **SEC. 2. REQUIREMENT FOR USE OF CDMA TECHNOLOGY IN**  
13                   **ANY CONTRACT FOR COMMERCIAL MOBILE**  
14                   **WIRELESS COMMUNICATION SERVICE PRO-**  
15                   **VIDED AS ASSISTANCE FOR IRAQ.**

16       In entering into any contract with a private entity  
17   to provide commercial mobile wireless communication  
18   service as assistance for Iraq, the Administrator of the  
19   United States Agency for International Development and  
20   the Secretary of Defense shall require that CDMA tech-  
21   nology be used for such communication service.

22   **SEC. 3. DEFINITIONS.**

23       In this Act:

24                   (1) AMERICAN ENTITY.—The term “American  
25   entity” means a company or other business entity  
26   that, as determined by the Administrator of the

1       United States Agency for International Development  
2       or the Secretary of Defense, is a company or other  
3       business entity the majority ownership or control of  
4       which is by United States citizens.

5               (2) COMMERCIAL MOBILE WIRELESS COMMU-  
6       NICATION SERVICE.—The term “commercial mobile  
7       wireless communication service” means any radio  
8       communication service carried on between mobile  
9       stations or receivers and land stations, and by mo-  
10       bile stations communicating among themselves, that  
11       is provided for profit and makes service available (A)  
12       to the public or (B) to such classes of eligible users  
13       as to be effectively available to a substantial portion  
14       of the public.

15               (3) CDMA TECHNOLOGY.—The term “CDMA  
16       technology” means code division multiple access  
17       technology.
