A BILL

To designate certain National Forest System lands in the Commonwealth of Puerto Rico as components of the National Wilderness Preservation System, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Caribbean National
- 5 Forest Act of 2003".

1 SEC. 2. WILDERNESS DESIGNATION, CARIBBEAN NATIONAL

3	(a) El Toro Wilderness.—In furtherance of the
4	purposes of the Wilderness Act (16 U.S.C. 113 et seq.),
5	the approximately 10,000 acres of land in the Caribbean
6	National Forest/Luquillo Experimental Forest in the
7	Commonwealth of Puerto Rico that were proposed for wil-
8	derness classification in the revised land and resource
9	management plan for the Caribbean National Forest/
10	Luquillo Experimental Forest, approved April 17, 1997,
11	are hereby designated as wilderness and, therefore, as a
12	component of the National Wilderness Preservation Sys-
13	tem. The designated lands shall be known as the El Toro
14	Wilderness.
15	(b) WILDERNESS BOUNDARIES.—The El Toro Wil-
16	derness shall consist of those lands that were proposed for
17	wilderness classification in the management plan referred
18	to in subsection (a), except that the Secretary of Agri-

- 24 (c) Map and Description.—
- (1) PREPARATION AND SUBMISSION.—As soon
 as practicable after the date of the enactment of this

- 1 Act, the Secretary of Agriculture shall prepare a
- 2 map and a boundary description of the El Toro Wil-
- derness and submit the map and boundary descrip-
- 4 tion to the Committee on Resources of the House of
- 5 Representatives and the Committee on Energy and
- 6 Natural Resources of the Senate. The map and
- 7 boundary description shall be on file and available
- 8 for public inspection in the office of the Chief of the
- 9 Forest Service.
- 10 (2) TREATMENT.—The map and boundary de-
- scription prepared under paragraph (1) shall have
- the same force and effect as if included in this Act.
- 13 The Secretary may correct clerical and typographical
- errors in the map and description.
- 15 (d) Administration.—Subject to valid existing
- 16 rights, the Secretary of Agriculture shall administer the

- 5 (1) Installation and maintenance of hydrologic, 6 meteorological, climatological, or atmospheric data 7 collection and transmission facilities, or any com-8 bination of such facilities, when the Secretary deter-9 mines that such facilities are essential to the sci-10 entific research purposes of the Luquillo Experi-11 mental Forest.
 - (2) Construction and maintenance of nesting structures, observation blinds, and population monitoring platforms for threatened and endangered species.
 - (3) Construction and maintenance of trails to such facilities as necessary for research purposes and for the recovery of threatened and endangered species.
