- 5 (a) In General.—Subparagraph (A) of section
- 6 168(i)(2) of the Internal Revenue Code of 1986 (defining
- 7 qualified technological equipment) is amended by striking
- 8 "and" at the end of clause (ii), by striking the period at

- 1 the end of clause (iii) and inserting ", and", and by adding
- 2 after clause (iii) the following new clause:
- 3 "(iv) any wireless telecommunications
- 4 equipment."
- 5 (b) Wireless Telecommunications Equip-
- 6 MENT.—Section 168(i)(2) of the Internal Revenue Code
- 7 of 1986 is amended by adding at the end the following
- 8 new subparagraph:
- 9 "(D) Wireless telecommunications
- 10 EQUIPMENT.—For purposes of this paragraph,
- 11 the term 'wireless telecommunications equip-
- ment' means all equipment used in the trans-
- mission, reception, coordination, or switching of
- 14 wireless telecommunications service, other than
- cell towers, buildings, T-1 lines or other cabling
- 16 connecting cell sites to mobile switching centers.
- 17 For purposes of the preceding sentence, the
- term 'wireless telecommunications service' in-
- 19 cludes any commercial mobile radio service as
- defined in title 47 of the Code of Federal Regu-
- 21 lations."
- (c) Effective Date.—The amendments made by
- 23 this section shall apply to property placed in service on
- 24 or after the date of the enactment of this Act.
