## A BILL

To amend title 38, United States Code, to provide housing loan benefits for the purchase of residential cooperative apartment units.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Housing
- 5 Fairness Act of 2003".

## 1 SEC. 2. RESIDENTIAL COOPERATIVE HOUSING UNITS.

- 2 (a) Housing Benefits for Cooperative Apart-
- 3 MENT UNITS.—Section 3710(a) of title 38, United States
- 4 Code, is amended by adding at the end the following new
- 5 paragraph:
- 6 "(12) To purchase stock or membership in a
- 7 development, project or structure of a cooperative
- 8 housing corporation in accordance with subsection
- 9 (h).".
- 10 (b) Conditions of Housing Benefits for Coop-
- 11 ERATIVE APARTMENT UNITS.—Section 3710 of such title
- 12 is amended by adding at the end the following new sub-
- 13 section:
- 14 "(h)(1) A loan may not be guaranteed under sub-
- 15 section (a)(12) unless the following conditions are met:
- 16 "(A) The development, project or structure of
- the cooperative housing corporation complies with
- such criteria as the Secretary prescribes in regula-
- 19 tions.
- 20 "(B) The dwelling unit, that the purchase of
- stock or membership in the development, project or
- structure of the cooperative housing corporation en-
- titles the purchaser to occupy, is a one-family resi-
- dential unit.

- 3 "(3) For the purposes of applying the term 'value of
- 4 the property' to a loan guaranteed under subsection
- 5 (a)(12), such term means the appraised value of the stock
- 6 or membership entitling the purchaser to the permanent
- 7 occupancy of the dwelling unit in the development, project
- 8 or structure of the cooperative housing corporation.".
