A BILL

To amend the Transportation Equity Act for the 21st Century with respect to NAFTA corridor planning and development and coordinated border infrastructure and safety.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. NAFTA CORRIDOR PLANNING AND DEVELOP-
- 4 MENT.
- 5 (a) ELIGIBILITY OF CORRIDORS.—Section 1118(b) of
- 6 the Transportation Equity Act for the 21st Century (23
- 7 U.S.C. 101 note; 112 Stat. 161) is amended to read as
- 8 follows:
- 9 "(b) Eligibility of Corridors.—

- 1 "(1) IN GENERAL.—The Secretary may make
- 2 allocations under this section with respect to high
- priority corridors identified in section 1105(c) of the
- 4 Intermodal Surface Transportation Efficiency Act of
- 5 1991 (105 Stat. 2032) that connect to the border
- 6 between the United States and Mexico or the United
- 7 States and Canada.
- 8 "(2) Priority.—In making allocations under
- 9 this section, the Secretary shall give priority consid-
- eration to corridors on which traffic has increased
- since the date of enactment of the North American
- 12 Free Trade Agreement Implementation Act and is
- projected to increase in the future.".
- (b) APPLICABILITY OF TITLE 23.—Section 1118(e)
- 15 of such Act (23 U.S.C. 101 note; 112 Stat. 162) is amend-
- 16 ed—
- 17 (1) by striking "by section 1101 of this Act";
- 18 and
- 19 (2) by striking "and section 1119".
- 20 (c) Authorization of Appropriations.—Section
- 21 1118 of such Act (23 U.S.C. 101 note; 112 Stat. 161)
- 22 is amended by adding at the end the following:
- 23 "(h) AUTHORIZATION OF APPROPRIATIONS.—There
- 24 is authorized to be appropriated out of the Highway Trust
- 25 Fund (other than the Mass Transit Account) to the Sec-

- 1 retary to carry out this section \$200,000,000 for each of
- 2 the fiscal years 2004 through 2009.".
- 3 (d) Conforming Amendments.—
- 4 (1) Section Heading.—The heading for sec-
- 5 tion 1118 of such Act (23 U.S.C. 101 note; 112
- 6 Stat. 161) is amended by striking "NATIONAL" and
- 7 inserting "**NAFTA**".
- 8 (2) Table of Contents.—Section 1(b) of
- 9 such Act (112 Stat. 107) is amended by striking the
- item relating to section 1118 and inserting the fol-
- 11 lowing:

"Sec. 1118. NAFTA corridor planning and development program.".

- 12 SEC. 2. COORDINATED BORDER INFRASTRUCTURE.
- 13 Section 1119 of the Transportation Equity Act for
- 14 the 21st Century (23 U.S.C. 101 note) is amended by add-
- 15 ing at the end the following:
- 16 "(f) Funding.—
- 17 "(1) Authorization of appropriations.—
- 18 There is authorized to be appropriated out of the
- 19 Highway Trust Fund (other than the Mass Transit
- Account) to the Secretary to carry out this section
- 21 \$200,000,000 for each of the fiscal years 2004
- through 2009.
- 23 "(2) APPLICABILITY OF TITLE 23.—Funds
- made available to carry out this section shall be
- available for obligation in the same manner as if

- 1 such funds were apportioned under chapter 1 of title
- 2 23, United States Code.".
