A BILL

To provide for the Secretary of Veterans Affairs to conduct a pilot program to determine the effectiveness of contracting for the use of private memory care facilities for veterans with Alzheimer's Disease.

1 Be it enacted by the Senate and House of Representa2 tives of the United States of America in Congress assembled,
3 SECTION 1. DEPARTMENT OF VETERANS AFFAIRS PILOT
4 PROGRAM OF USE OF PRIVATE MEMORY
5 CARE FACILITIES FOR VETERANS WITH ALZ6 HEIMER'S DISEASE.
7 (a) PILOT PROGRAM.—The Secretary of Veterans Af-

fairs shall conduct a pilot program to determine the effec-

- 1 tiveness of contracting with private memory care facilities
- 2 to provide needed services for veterans suffering from Alz-
- 3 heimer's Disease as an alternative to the provision by the
- 4 Secretary of inpatient care or home health care for such
- 5 veterans.
- 6 (b) Scope of Pilot Program.—(1) The pilot pro-
- 7 gram shall be conducted through five medical centers of
- 8 the Veterans Health Administration selected by the Sec-
- 9 retary for such purpose.
- 10 (2) The program shall be conducted during fiscal
- 11 years 2004 and 2005.
- 12 (3) Under the pilot program, the Secretary may con-
- 13 tract for services for eligible veterans from private memory
- 14 care facilities. Any such contract shall be entered into in
- 15 the same manner as applies to contracts under section
- 16 1703 of title 38, United States Code.
- 17 (c) Report.—Upon the conclusion of the pilot pro-
- 18 gram, the Secretary shall submit to Congress a report pro-
- 19 viding the results of the pilot program. The report shall
- 20 be submitted not later than 90 days after the end of the
- 21 pilot program. The Secretary shall include in the report
- 22 the following:
- 23 (1) The Secretary's assessment of the benefits
- 24 to veterans of the pilot program.

1	(2) The Secretary's assessment of the effect of
2	the pilot program on the Department of Veterans
3	Affairs, including the effect on delivery of health
4	care to veterans suffering from Alzheimer's disease
5	or related memory disorders.
6	(3) Any other findings and conclusions of the
7	Secretary with respect to the pilot program.
8	(4) Any recommendations of the Secretary
9	for—
10	(A) continuation of the pilot program;
11	(B) extension of the pilot program to other
12	service regions or to all service regions of the
13	Department of Veterans Affairs; or
14	(C) for making the authority to enter into
15	contracts as described in subsection (b)(3) a
16	permanent authority under section 1703 of title
17	38, United States Code.
18	(d) Memory Care Facilities.—For purposes of
19	this section, the term "memory care facility" means a fa-
20	cility that provides specialized services and housing that
21	are tailored to the individual needs of those suffering from
22	Alzheimer's disease or related memory disorders.
