## A BILL

- To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize certain projects in the State of Hawaii and to amend the Hawaii Water Resources Act of 2000 to modify the water resources study.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Hawaii Water Re-
  - 5 sources Act of 2003".

### 1 SEC. 2. HAWAII RECLAMATION PROJECTS.

2	(a) In General.—The Reclamation Wastewater and
3	Groundwater Study and Facilities Act (43 U.S.C. 390h
4	et seq.) is amended by adding at the end the following:
5	"SEC. 1636. HAWAII RECLAMATION PROJECTS.
6	"(a) AUTHORIZATION.—The Secretary may—
7	"(1) in cooperation with the Board of Water
8	Supply, City and County of Honolulu, Hawaii, par-
9	ticipate in the design, planning, and construction of
10	a project in Kalaeloa, Hawaii, to desalinate and dis-
11	tribute seawater for direct potable use within the
12	service area of the Board;
13	"(2) in cooperation with the County of Hawaii
14	Department of Environmental Management, Hawaii,
15	participate in the design, planning, and construction
16	of facilities in Kealakehe, Hawaii, for the treatment
17	and distribution of recycled water and for environ-
18	mental purposes within the County; and
19	"(3) in cooperation with the County of Maui
20	Wastewater Reclamation Division, Hawaii, partici-
21	pate in the design, planning, and construction of,
22	and acquire land for, facilities in Lahaina, Hawaii,
23	for the distribution of recycled water from the
24	Lahaina Wastewater Reclamation Facility for non-
25	potable uses within the County.

- 1 "(b) Cost Share.—The Federal share of the cost
- 2 of a project described in subsection (a) shall not exceed
- 3 25 percent of the total cost of the project.
- 4 "(c) Limitation.—Funds provided by the Secretary
- 5 shall not be used for the operation and maintenance of
- 6 a project described in subsection (a).
- 7 "(d) AUTHORIZATION OF APPROPRIATIONS.—There
- 8 are authorized to be appropriated such sums as are nec-
- 9 essary to carry out this section.".
- 10 (b) Conforming Amendment.—The table of sec-
- 11 tions in section 2 of the Reclamation Projects Authoriza-
- 12 tion and Adjustment Act of 1992 (43 U.S.C. prec. 371)
- 13 is amended by inserting after the item relating to section
- 14 1634 the following:

"Sec. 1636. Hawaii reclamation projects.".

#### 15 SEC. 3. HAWAII WATER RESOURCES STUDY.

- 16 The Hawaii Water Resources Act of 2000 is amend-
- 17 ed—
- 18 (1) in section 103(e) (114 Stat. 2819), by strik-
- ing "\$300,000" and inserting "\$2,000,000"; and
- 20 (2) in section 104(b) (114 Stat. 2819), by
- striking "cost-effective," and all that follows through
- the period at the end and inserting "cost-effective.".
