- 3 (a) Efforts to Provide Alternative Grazing
- 4 Arrangements.—The Secretary of Agriculture shall un-
- 5 dertake best efforts to provide suitable alternative grazing
- 6 arrangements on other National Forest System land to a
- 7 person that holds a permit to graze on National Forest
- 8 System land if the Secretary determines that the permit-
- 9 tee's grazing privileges will be limited by implementation
- 10 of the standards and guidelines pertaining to the willow
- 11 flycatcher and the Yosemite Toad that are contained in
- 12 the Record of Decision of the Sierra Nevada Forest Plan
- 13 Amendment (referred to in this section as the "guide-
- 14 lines").
- 15 (b) CATEGORICAL EXCLUSION.—The Secretary may
- 16 provide, consistent with section 102 of the National Envi-
- 17 ronmental Policy Act of 1969 (42 U.S.C. 4332), a categor-
- 18 ical exclusion from that Act for alternative grazing ar-
- 19 rangements provided under subsection (a) without first
- 20 administratively establishing an applicable category of ex-
- 21 cluded actions. No scoping shall be required for any such
- 22 categorical exclusion.
- 23 (c) Delayed Applicability.—Notwithstanding the
- 24 Forest and Rangeland Renewable Resources Planning Act
- 25 of 1974 (16 U.S.C. 1600 et seq.), the guidelines shall not
- 26 apply during calendar year 2003 to grazing activities on

- 1 any of the following severely affected allotments for which
- 2 the Secretary is unable to provide alternative arrange-
- 3 ments:
- 4 (1) The Sardine allotment on the Humboldt-
- 5 Toiyabe National Forest.
- 6 (2) The Feather River, Soda Creek/North
- 7 Butte, and Robbers Creek allotments on the Lassen
- 8 National Forest.
- 9 (3) The Doyle allotment on the Plumas Na-
- tional Forest.
- 11 (4) The Blasingame, Dinkey, Iron Creek, Kai-
- ser, Markwood, Mount Tom, Patterson Mountain,
- and South Jackass allotments on the Sierra Na-
- 14 tional Forest.
- 15 (5) The Long Valley/Eagle Meadow, Highland
- 16 Lakes, Cooper, and Herring allotments on the
- 17 Stanislaus National Forest.
- 18 (6) The Parazzo and Gold Valley allotments on
- the Tahoe National Forest.
- 20 (d) Issuance of Direction.—Without regard to
- 21 any other proceeding otherwise required by law, the Sec-
- 22 retary shall issue direction as soon as practicable for cal-
- 23 endar year 2003 to minimize harm to the Willow
- 24 Flycatcher and the Yosemite Toad from the grazing activi-
- 25 ties permitted under this section. The Secretary shall hold

- 1 a public meeting in the Stanislaus National Forest and
- 2 in the Sierra National Forest before issuing such direc-
- 3 tion. The Secretary shall not be required to amend or re-
- 4 vise any land and resource management plan to issue such
- 5 direction, and shall not be required to comply with any
- 6 other procedures otherwise required by law before issuing

7 such direction.
