AN ACT

To establish a commission to commemorate the sesquicentennial of the American Civil War.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Civil War Sesqui-
- 3 centennial Commission Act".

- 4 SEC. 2. FINDINGS AND PURPOSE.
- 5 (a) FINDINGS.—Congress makes the following find-6 ings:
- 7 (1) The American Civil War was a defining ex-8 perience in the development of the United States.
 - (2) The people of the United States continue to struggle with issues of race, civil rights, the politics of federalism, and heritage which are legacies of the Civil War and Reconstruction.
 - (3) There is a resurgence of interest in the Civil War that is evidenced by the multitude of publications, exhibits, reenactments, research organizations, Internet and multimedia resources, historic parks, and preservation associations focused on the Civil War.
 - (4) The years 2011 through 2015 mark the sesquicentennial of the Civil War.
 - (5) The sesquicentennial of the Civil War presents a significant opportunity for Americans to recall and reflect upon the Civil War and its legacy in a spirit of reconciliation and reflection.

| 11 | section shall be used for appropriate activities relating to |

| 19 | SEC. 8. POWERS OF THE COMMISSION. |
| 20 | (a) In General.—The Commission may— |
| 21 | (1) solicit, accept, use, and dispose of gifts, be- |
| 22 | quests, or devises of money or other real or personal |
| 23 | property for the purpose of aiding or facilitating the |
| 24 | work of the Commission: |

- 1 (2) appoint any advisory committee as the 2 Commission considers appropriate for the purposes 3 of this Act;
 - (3) authorize any voting member or employee of the Commission to take any action that the Commission is authorized to take under this Act;
 - (4) procure supplies, services, and property, and make or enter into contracts, leases, or other legal agreements to carry out this Act (except that any contracts, leases, or other legal agreements entered into by the Commission shall not extend beyond the date of the termination of the Commission); and
- 13 (5) use the United States mails in the same 14 manner and under the same conditions as other 15 Federal agencies.

16 SEC. 9. PERSONNEL MATTERS.

- 17 (a) COMPENSATION OF MEMBERS.—Members of the 18 Commission, and members of any advisory committee ap-
- 19 pointed under section 8(a)(2), shall serve without com-
- 20 pensation.

- 21 (b) Travel Expenses.—Members of the Commis-
- 22 sion, and members of any advisory committees appointed
- 23 under section 8(a)(2), shall be allowed travel expenses, in-
- 24 cluding per diem in lieu of subsistence, at rates authorized
- 25 for an employee of an agency under subchapter I of chap-

- 5 (1) IN GENERAL.—The Chairperson of the 6 Commission may, without regard to civil service laws 7 (including regulations), appoint and terminate an ex-8 ecutive director and such other additional personnel 9 as are necessary to enable the Commission to per-10 form the duties of the Commission.
 - (2) CONFIRMATION OF EXECUTIVE DIRECTOR.—The employment of an executive director shall be subject to confirmation by the Commission.

(3) Compensation.—

- (A) IN GENERAL.—Except as provided in subparagraph (B), the Chairperson of the Commission may fix the compensation of the executive director and other personnel without regard to the provisions of chapter 51 and subchapter III of chapter 53 of title 5, United States Code, relating to classification of positions and General Schedule pay rates.
- (B) MAXIMUM RATE OF PAY.—The rate of pay for the executive director and other personnel shall not exceed the rate payable for

- level V of the Executive Schedule under section 5316 of title 5, United States Code.
- 3 (d) Detail of Government Employees.—
- (1) IN GENERAL.—At the request of the Commission, the head of any Federal agency may detail, on a reimbursable or nonreimbursable basis, any of the personnel of the agency to the Commission to assist the Commission in carrying out the duties of the Commission under this Act.
- 10 (2) CIVIL SERVICE STATUS.—The detail of an 11 employee under paragraph (1) shall be without inter-12 ruption or loss of civil service status or privilege.
- 13 (e) Volunteer and Uncompensated Services.—
- 14 Notwithstanding section 1342 of title 31, United States
- 15 Code, the Commission may accept and use voluntary and
- 16 uncompensated services as the Commission determines
- 17 necessary.
- 18 (f) Support Services.—The Director of the Na-
- 19 tional Park Service shall provide to the Commission, on
- 20 a reimbursable basis, such administrative support services
- 21 as the Commission may request.
- 22 (g) Procurement of Temporary and Intermit-
- 23 TENT SERVICES.—The Chairperson of the Commission
- 24 may procure temporary and intermittent services under
- 25 section 3109(b) of title 5, United States Code, at daily

- 1 rates for individuals which do not exceed the daily equiva-
- 2 lent of the annual rate of basic pay prescribed for level
- 3 V of the Executive Schedule under section 5316 of such
- 4 title.
- 5 (h) FACA NONAPPLICABILITY.—Section 14(b) of the
- 6 Federal Advisory Committee Act (5 U.S.C. App.) shall not
- 7 apply to the Commission.
- 8 (i) Termination.—The Commission shall terminate
- 9 on the date that is 90 days after the date on which the
- 10 Commission submits its report under section 6(b)(2).

11 SEC. 10. AUDIT OF COMMISSION.

- 12 The Inspector General of the Department of the Inte-
- 13 rior shall perform an annual audit of the Commission and
- 14 shall make the results of the audit available to the public.

15 SEC. 11. AUTHORIZATION OF APPROPRIATIONS.

- 16 (a) In General.—There is authorized to be appro-
- 17 priated to carry out this Act (other than section 7)
- 18 \$200,000 for each of the fiscal years 2005 through 2016.
- 19 (b) Grants.—There is authorized to be appropriated
- 20 \$3,500,000 to the National Endowment for the

- 1 Humanities to provide grants under section 7, to remain
- 2 available until expended.
