# A BILL

To provide grants to States to establish, expand, or enhance prekindergarten programs for children who are not yet enrolled in kindergarten.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Prekindergarten Ac-
- 5 cess Act of 2003".
- 6 SEC. 2. PREKINDERGARTEN PROGRAM.
- 7 Title V of the Elementary and Secondary Education
- 8 Act of 1965 is amended by adding at the end the fol-
- 9 lowing:

- 3 "Congress finds the following:
- "(1) Countless studies have shown what every parent already knows: High-quality preschool education programs work. They prepare children to learn when they go to school, and the programs increase the success of students throughout their lives.
  - "(2) Children who get a high-quality prekindergarten education are less likely to repeat a grade level and have less need for special education instruction than those with no prekindergarten experience.
  - "(3) Prekindergarten programs make a significant difference in the lives of children from low-income families. A recent study found that children in high-quality child care programs had better thinking and attention skills, better mathematics and prereading skills, and fewer behavioral problems.
  - "(4) In a study following children to age 21 who received high-quality early children education, such children were more likely to have enrolled in college, been employed, and delayed parenthood.

#### 24 **"SEC. 5702. DEFINITIONS.**

25 "For purposes of this part, the following definitions 26 shall apply:

- "(1) Prekindergarten.—The term 'prekindergarten' means a program serving children ages 3, 4, and 5 years old that supports children's cognitive, social, emotional, and physical development and helps prepare children for the transition to kindergarten.
  - "(2) ELIGIBLE PREKINDERGARTEN PRO-VIDERS.—The term 'eligible prekindergarten providers' includes child care programs, Head Start agencies, and schools that—
    - "(A) have met applicable State licensing requirements and have obtained accreditation by a national accrediting body with demonstrated experience in accrediting child care, prekindergarten programs, or schools; or
  - "(B) agree to obtain such accreditation not later than 3 years after receipt of a grant under this part.
- "(3) Prekindergarten Teacher.—The term
  prekindergarten teacher' means an individual who
  has or is working toward a bachelor of arts degree
  in early childhood development.

#### 23 "SEC. 5703. PROGRAM AUTHORIZED.

24 "(a) In General.—The Secretary is authorized to 25 provide grants to a State with an approved application

7	"(b) STATE APPLICATION.—
8	"(1) In general.—The State shall designate a

14	agency shall submit an application to the Secretary

24	"(ii) how the State will collaborate
25	with local child care agencies and councils.

17	to full-time prekindergarten programs, in-
18	cluding the expansion of existing part-time
19	programs into full-time programs.
20	"SEC. 5704. LOCAL APPLICATIONS.
21	"(a) In General.—A local educational agency or eli-
22	gible prekindergarten provider, as the case may be, that
23	desires to receive a grant under this part shall submit an
24	application to the State agency designated under section

- 1 5703(b) at such time, in such manner, and containing
- 2 such information as such agency may reasonably require.
- 3 "(b) Special Rule.—If the State prekindergarten
- 4 program is not operated through the local educational
- 5 agency, then the State shall award subgrants to eligible
- 6 prekindergarten providers that currently administer pre-
- 7 kindergarten programs at the local level.
- 8 "(c) Content.—An application referred to in sub-
- 9 section (a), at a minimum, shall—
- "(1) demonstrate a need for the establishment,
- enhancement, or expansion of a prekindergarten pro-
- 12 gram;
- "(2) describe how the local educational agency
- or eligible prekindergarten provider collaborates with
- local early childhood councils and agencies;
- 16 "(3) provide an assurance that each individual
- hired is qualified to teach children at the prekinder-
- 18 garten level;
- 19 "(4) provide an assurance that the ratio of
- teachers or child development specialists to children
- shall not exceed 1–10;
- 22 "(5) provide a description of how funds will be
- used to coordinate with and enhance, but not dupli-
- cate or supplant, early childhood programs serving
- eligible children that exist in the community;

- "(6) describe how the agency or eligible prekindergarten provider will use a collaborative process with organizations and members of the community that have an interest and experience in early childhood development and education to establish, expand, or enhance prekindergarten programs;
  - "(7) describe how the program will meet the diverse needs of children, ages 3 through 5, in the community who are not enrolled in kindergarten, including children with disabilities or whose native language is other than English;
  - "(8) describe how the agency or eligible prekindergarten provider will collaborate with local schools to ensure a smooth transition for participating students from early childhood education to kindergarten and early elementary education;
  - "(9) describe the results the programs are intended to achieve, and what tools will be used to measure the progress in attaining those results; and
  - "(10) provide an assurance that none of the funds received under this part may be used for the construction or renovation of existing or new facilities (except for minor remodeling needed to accomplish the purposes of this part).

## 1 "SEC. 5705. USES OF FUNDS.

2	"(a) In General.—An agency or eligible prekinder-
3	garten provider that receives a grant award under this
4	part shall use funds received to establish, enhance, or ex-
5	pand prekindergarten programs for children, ages 3
6	through 5, who are not enrolled in kindergarten, includ-

8	"(1) providing a program that focuses on the

15	"(2) paying the costs of purchasing educational
16	equipment, including educational materials, nec-
17	essary to provide a high quality program;
18	"(3) pursuing accreditation by a national ac-
19	creditation body with demonstrated experience in ac-
20	creditation of prekindergarten programs, to be ob-
21	tained not later than 3 years after the date of re-
22	ceipt of funds under this part;
23	"(4) helping prekindergarten teachers pursue
24	and attain the credential and degree requirements

established by the State and provide a stipend for

- 2 and
- 3 "(5) meeting the needs of working parents.
- 4 "(b) Permissible Uses of Funds.—A prekinder-
- 5 garten program established under this part may use funds
- 6 received under this part to pay for transporting students
- 7 to and from a prekindergarten program.
- 8 "SEC. 5706. REPORTING.
- 9 "(a) Local Reports.—Each local educational agen-
- 10 cy or eligible prekindergarten provider that receives a
- 11 grant award under this part shall submit an annual report
- 12 to the designated State agency that reviews the effective-
- 13 ness of the prekindergarten program established with
- 14 funds provided under this part on—
- 15 "(1) number and ages of children served, in-
- 16 cluding information (disaggregated by family in-
- 17 come, race, disability, native language);
- 18 "(2) number of hours of service per day and
- 19 number of months;
- 20 "(3) number of prekindergarten teachers; and
- 21 "(4) other sources of Federal, State, local, and
- private funds used to operate a program.
- 23 "(b) Report to Congress.—The Secretary shall
- 24 submit an annual report to Congress that evaluates the
- 25 prekindergarten programs established under this part.

#### 1 "SEC. 5707. AUTHORIZATION OF APPROPRIATIONS.

- 2 "There are authorized to be appropriated to carry out
- 3 this part \$2,000,000,000 for fiscal year 2003,
- 4 \$4,000,000,000 for fiscal year 2004, \$5,000,000,000 for
- 5 fiscal year 2005, \$8,000,000,000 for fiscal year 2006, and
- 6 \$10,000,000,000 for fiscal year 2007.".
