A BILL

To amend the Soldiers' and Sailors' Civil Relief Act of 1940 to enhance the protection of credit ratings of active duty military personnel who are activated for military service.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Heroes Credit
- 5 Protection Act".

SEC. 2. PROTECTION OF CREDIT RATINGS OF PERSONS AC-

- 2 TIVATED FOR MILITARY SERVICE.
- 3 (a) Credit Rating Protection.—The Soldiers'
- 4 and Sailors' Civil Relief Act of 1940 (50 U.S.C. App. 501
- 5 et seq.) is amended by inserting at the end of article I
- 6 the following new section:
- 7 "Sec. 109. (a) Any person or entity engaged in the
- 8 practice of assembling or evaluating consumer credit infor-
- 9 mation that receives from a creditor a negative report of
- 10 nonpayment or late payment with respect to a qualifying
- 11 account of a person in military service shall enter with
- 12 that negative report a notation that the account is delin-
- 13 quent or paid slowly due to military service.
- 14 "(b) Any future potential creditor of such person who
- 15 receives a credit report that includes a notation required
- 16 by subsection (a) shall disregard any negative information
- 17 so noted in the credit report.
- 18 "(c) For purposes of this section, a qualifying ac-
- 19 count is an account that was opened by a person in mili-
- 20 tary service before the date on which that person entered
- 21 that period of military service, but only with respect to
- 22 obligations incurred before such date.".
- 23 (b) Effective Date.—Section 109 of the Soldiers'
- 24 and Sailors' Civil Relief Act of 1940, as added by sub-
- 25 section (a), shall apply with respect to a period of military
- 26 service (as defined in such Act) that is being performed

- 1 by a person on the date of the enactment of this Act or
- 2 to which a person is ordered on or after such date.
