## A BILL

To amend title 10, United States Code, to provide that consensual sexual activity between adults shall not be a violation of the Uniform Code of Military Justice.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Anti-Hypocrisy Act  
5 of 2003”.

1 **SEC. 2. REMOVAL OF CONSENSUAL SEXUAL ACTIVITY BE-**  
2 **TWEEN ADULTS AS BASIS FOR PROSECUTION**  
3 **UNDER THE UNIFORM CODE OF MILITARY**  
4 **JUSTICE.**

5 (a) SODOMY.—Section 925 of title 10, United States  
6 Code (article 125 of the Uniform Code of Military Jus-  
7 tice), is amended—

8 (1) by inserting “nonconsensual” after “en-  
9 gages in”; and

10 (2) by inserting “carnal copulation” before  
11 “with an”.

12 (b) CONDUCT UNBECOMING AN OFFICER AND A  
13 GENTLEMAN.—Section 933 of such title (article 133 of  
14 such Code) is amended—

15 (1) by inserting “(a)” before “Any commis-  
16 sioned”; and

17 (2) by adding at the end the following:

18 “(b) Neither of the following shall be the basis for  
19 a prosecution under this section:

20 “(1) A consensual act of a sexual nature that  
21 is between adults and that does not involve com-  
22 pensation.

23 “(2) Cohabitation by adults.”.

24 (c) GENERAL ARTICLE.—Section 934 of such title  
25 (article 134 of such Code) is amended—

1           (1) by inserting “(a)” before “Though not”;  
2       and

3           (2) by adding at the end the following:

4       “(b) Neither of the following shall be the basis for  
5 a prosecution under this section:

6           “(1) A consensual act of a sexual nature that  
7       is between adults and that does not involve com-  
8       pensation.

9           “(2) Cohabitation by adults.”.

10       (d) CONSTRUCTION OF AMENDMENTS.—Nothing in  
11 the amendments made by this section shall be—

12           (1) construed to prevent prosecution under the  
13       Uniform Code of Military Justice for acts of frater-  
14       nization; or

15           (2) considered to prevent noncriminal discipli-  
16       nary action or administrative proceedings against a  
17       person subject to the Uniform Code of Military Jus-  
18       tice for misconduct (sexual or otherwise) that—

19           (A) constitutes a disorder and neglect to  
20       the prejudice of good order and discipline in the  
21       Armed Forces;

22           (B) is of a nature to bring discredit upon  
23       the Armed Forces; or

1                   (C) in the case of a commissioned officer,  
2           cadet, or midshipman, constitutes conduct un-  
3           becoming an officer and a gentleman.
