- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "FERS Redeposit Act".

## 1 SEC. 2. DEPOSIT AUTHORITY.

- 2 Section 8422 of title 5, United States Code, is
- 3 amended by adding at the end the following:
- 4 "(i)(1) Each employee or Member who has received
- 5 a refund of retirement deductions under this or any other
- 6 retirement system established for employees of the Gov-
- 7 ernment covering service for which such employee or Mem-
- 8 ber may be allowed credit under this chapter may deposit
- 9 the amount received, with interest. Credit may not be al-
- 10 lowed for the service covered by the refund until the de-
- 11 posit is made.
- 12 "(2) Interest under this subsection shall be computed
- 13 in accordance with paragraphs (2) and (3) of section
- 14 8334(e) and regulations prescribed by the Office. The op-
- 15 tion under the third sentence of section 8334(e)(2) to
- 16 make a deposit in one or more installments shall apply
- 17 to deposits under this subsection.
- 18 "(3) For the purpose of survivor annuities, deposits
- 19 authorized by this subsection may also be made by a sur-
- 20 vivor of an employee or Member.".
- 21 SEC. 3. TECHNICAL AND CONFORMING AMENDMENTS.
- 22 (a) Definitional Amendment.—Section
- 23 8401(19)(C) of title 5, United States Code, is amended
- 24 by striking "8411(f);" and inserting "8411(f) or
- 25 8422(i);".

- 1 (b) Crediting of Deposits.—Section 8422(c) of
- 2 title 5, United States Code, is amended by adding at the
- 3 end the following: "Deposits made by an employee, Mem-
- 4 ber, or survivor also shall be credited to the Fund.".
- 5 (c) Section Heading.—(1) The heading for section
- 6 8422 of title 5, United States Code, is amended to read
- 7 as follows:
- 8 "§ 8422. Deductions from pay; contributions for mili-
- 9 tary service; deposits".
- 10 (2) The analysis for chapter 84 of title 5, United
- 11 States Code, is amended by striking the item relating to
- 12 section 8422 and inserting the following:

"8422. Deductions from pay; contributions for military service; deposits.".

- 13 (d) Restoration of Annuity Rights.—The last
- 14 sentence of section 8424(a) of title 5, United States Code,
- 15 is amended by striking "based." and inserting "based,
- 16 until the employee or Member is reemployed in the service
- 17 subject to this chapter.".
