### l SECTION 1. UPPER SAN JOAQUIN RIVER BASIN STUDY.

- 2 (a) Short Title.—This section may be cited as the
- 3 "San Joaquin River Restoration Act".
- 4 (b) AUTHORIZATION.—Not later than 3 years after
- 5 the date of the enactment of this section, the Secretary
- 6 of the Interior shall complete a feasibility study of the
- 7 Upper San Joaquin River Basin in California, to deter-
- 8 mine the feasibility of increasing the capacity of water
- 9 storage, increasing power generation, improving water
- 10 supply reliability and quality, improving water manage-
- 11 ment efficiency, and improving ecosystem function and
- 12 flood control on the San Joaquin River through the con-
- 13 struction of a reservoir at Temperance Flat and other rea-
- 14 sonable measures.
- 15 (c) Matching Funds.—
- 16 (1) MATCH REQUIRED.—Before conducting the
- study under this section, the Secretary shall require
- assurances that fifty percent of the cost of the study
- shall be paid with local funds.
- 20 (2) Source of local funds.—Local funds
- 21 required under paragraph (1) shall be provided from
- the Central Valley Project Restoration Fund estab-
- lished under section 3407 of the Central Valley
- 24 Project Improvement Act (Public Law 102–575).
- 25 (d) Federal Cost Nonreimbursable.—Federal
- 26 funds expended for the study shall not be reimbursed.

- 1 (e) AUTHORIZATION OF APPROPRIATIONS.—There
- 2 are authorized to be appropriated such sums as are nec-

3 essary to carry out this section.
