- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans' Right to an
- 5 Attorney Act of 2003".

4	(a) Repeal.—Section 5904(c) of title 38, United
5	States Code, is amended—
6	(1) by striking paragraphs (1) and (3);
7	(2) by striking "(e)" and all that follows
8	through "(2) A person" and inserting "(c) A per-
9	son''; and
10	(3) in the first sentence—
11	(A) by striking "in a case referred to in
12	paragraph (1) of this subsection" and inserting
13	"in connection with a proceeding with respect
14	to benefits under laws administered by the Sec-
15	retary"; and
16	(B) by striking "after the Board first
17	makes a final decision in the case".
18	(b) Conforming Amendments.—
19	(1) Section 5905 of such title is amended—
20	(A) by striking "Whoever" and inserting
21	"(a) Whoever";
22	(B) by striking "in sections 5904 or 1984
23	of this title" and inserting "in subsection (b) of
24	this section"; and
25	(C) by adding at the end the following new
26	subsection:

- 1 "(b) Subsection (a)(1) does not apply to a fee or com-
- 2 pensation for services as provided in section 1984 of this
- 3 title or in connection with a proceeding with respect to
- 4 benefits under laws administered by the Secretary, except
