## A BILL

To extend the date for the submittal of the final report of the National Commission on Terrorist Attacks on the United States, to provide additional funding for the Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF NATIONAL COMMISSION ON**  
4 **TERRORIST ATTACKS ON THE UNITED**  
5 **STATES.**

6 (a) EXTENSION.—Section 610(b) of the Intelligence  
7 Authorization Act for Fiscal Year 2003 (Public Law 107–

1 306; 6 U.S.C. 101 note; 116 Stat 2413) is amended by  
2 striking “18 months after the date of the enactment of  
3 this Act” and inserting “January 10, 2005”.

4 (b) ADDITIONAL FUNDING.—Section 611 of such Act  
5 (6 U.S.C. 101 note; 116 Stat 2413) is amended—

6 (1) by redesignating subsection (b) as sub-  
7 section (c);

8 (2) by inserting after subsection (a) the fol-  
9 lowing new subsection (b):

10 “(b) ADDITIONAL FUNDING FROM THE NATIONAL  
11 FOREIGN INTELLIGENCE PROGRAM.—In addition to the  
12 amounts made available to the Commission under sub-  
13 section (a), of the amounts authorized to be appropriated  
14 by the Intelligence Authorization Act for Fiscal Year 2004  
15 (Public Law 108–177) and available in the Department  
16 of Defense Appropriations Act, 2004 (Public Law 108–  
17 87) for the National Foreign Intelligence Program, not  
18 more than \$6,000,000 shall be available for transfer to  
19 the Commission for purposes of the activities of the Com-  
20 mission under this title.”; and

21 (3) in subsection (c), as so redesignated by  
22 paragraph (1), by striking “subsection (a)” and in-  
23 serting “this section”.
