A BILL

To amend title 18, United States Code, to provide expanded protections against the misuse of public safety officer uniforms, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Badge and Uniform
- 5 Security and Trustworthiness Act of 2003".
- 6 SEC. 2. PUBLIC SAFETY OFFICER UNIFORMS.
- 7 (a) In General.—Section 716 of title 18, United
- 8 States Code, is amended—

1	(1) by striking "police badge" each place it ap-
2	pears in subsections (a) and (b) and inserting "pub-
3	lic safety officer insignia or article of clothing";
4	(2) in each of paragraphs (2) and (4) of sub-
5	section (a), by striking "badge of the police" and in-
6	serting "public safety officer insignia or article of
7	clothing";
8	(3) in subsection (b)—
9	(A) by striking "the badge" and inserting
10	"the insignia or article of clothing"; and
11	(B) by striking paragraphs (2) and (4);
12	(4) so that subsection (c) reads as follows:
13	"(c) As used in this section—
14	"(1) the term 'genuine public safety officer in-
15	signia or article of clothing' means an article of dis-
16	tinctive clothing or insignia, including a badge, em-
17	blem or identification card, that is an indicium of
18	the authority of a public safety officer;
19	"(2) the term 'public safety officer' means any
20	officer or employee of a Federal law enforcement
21	agency or of any State, or local law enforcement
22	agency; and
23	"(3) the term 'Federal law enforcement agency'
24	means the Bureau of Citizenship and Immigration
25	Services the Bureau of Customs and Border Protec-

- 2 forcement, the Transportation Safety Agency, the
- Federal Bureau of Investigation, the Drug Enforce-
- 4 ment Administration, the Secret Service, the Coast
- 5 Guard, the Bureau of Alcohol, Tobacco, and Fire-
- 6 arms, the Federal Marshal Service, the United
- 7 States Park Police, the United States Capitol Police,
- 8 and any other Federal entity determined to be a law
- 9 enforcement agency by the Attorney General or the
- 10 Secretary of Homeland Security."; and
- 11 (5) in the heading for the section, by striking
- 12 "Police badges" and inserting "Public safety officer
- insignia and clothing".
- 14 (b) Conforming Amendment to Table of Sec-
- 15 Tions.—The item in the table of sections at the beginning
- 16 of chapter 33 of title 18, United States Code, relating to
- 17 section 716 is amended by striking "Police badges" and
- 18 inserting "Public safety officer insignia and clothing".

19 SEC. 3. DIRECTION TO SENTENCING COMMISSION.

- The United States Sentencing Commission is directed
- 21 to make appropriate amendments to sentencing guidelines,
- 22 policy statements, and official commentary to assure that
- 23 the sentence imposed on a defendant who is convicted of
- 24 a Federal offense while wearing or displaying public safety
- 25 officer insignia and clothing received in violation of section

- 1 716 of title 18. United States Code, reflects the gravity
- 2 of this aggravating factor.
