## A BILL

To amend title XIX of the Social Security Act to permit States the option to provide Medicaid coverage for lowincome individuals infected with HIV.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Early Treatment for
5	HIV Act of 2004".
6	SEC. 2. OPTIONAL MEDICAID COVERAGE OF LOW-INCOME
7	HIV-INFECTED INDIVIDUALS.
8	(a) In General.—Section 1902 of the Social Secu-
9	rity Act (42 U.S.C. 1396a) is amended—
10	(1) in subsection (a)(10)(A)(ii)—
11	(A) by striking "or" at the end of sub-
12	clause (XVII);
13	(B) by adding "or" at the end of subclause
14	(XVIII); and
15	(C) by adding at the end the following:
16	"(XIX) who are described in sub-
17	section (cc) (relating to HIV-infected
18	individuals);"; and
19	(2) by adding at the end the following:
20	"(cc) HIV-infected individuals described in this sub-
21	section are individuals not described in subsection
22	(a)(10)(A)(i)—
23	"(1) who have HIV infection;
24	"(2) whose income (as determined under the
25	State plan under this title with respect to disabled

- 14 1902(a)(10)(A)(ii)(XVIII)" and inserting "subclause
- 15 (XVIII) or (XIX) of section 1902(a)(10)(A)(ii)".
- 16 (c) Conforming Amendments.—Section 1905(a) of
- 17 the Social Security Act (42 U.S.C. 1396d(a)) is amended
- 18 in the matter preceding paragraph (1)—
- 19 (1) by striking "or" at the end of clause (xii);
- 20 (2) by adding "or" at the end of clause (xiii);
- 21 and
- 22 (3) by inserting after clause (xiii) the following:
- 23 "(xiv) individuals described in section
- 24 1902(cc);".

- 1 (d) Exemption From Funding Limitation for
- 2 Territories.—Section 1108(g) of the Social Security
- 3 Act (42 U.S.C. 1308(g)) is amended by adding at the end
- 4 the following:
- 5 "(3) Disregarding medical assistance for
- 6 OPTIONAL LOW-INCOME HIV-INFECTED INDIVID-
- 7 UALS.—The limitations under subsection (f) and the
- 8 previous provisions of this subsection shall not apply
- 9 to amounts expended for medical assistance for indi-
- viduals described in section 1902(cc) who are only
- eligible for such assistance on the basis of section
- 12 1902(a)(10)(A)(ii)(XIX).".
- (e) Effective Date.—The amendments made by
- 14 this section shall apply to calendar quarters beginning on
- 15 or after the date of the enactment of this Act, without
- 16 regard to whether or not final regulations to carry out
- 17 such amendments have been promulgated by such date.
