A BILL

To reclassify fees paid into the Nuclear Waste Fund as offsetting collections, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. NUCLEAR WASTE FUND MANAGEMENT.

- 2 (a) Offsetting Collections.—Beginning on Octo-
- 3 ber 1, 2004, and continuing through September 30, 2009,
- 4 fees collected by the Secretary of Energy and deposited into
- 5 the Nuclear Waste Fund under the Nuclear Waste Policy
- 6 Act of 1982 (42 U.S.C. 10101 et seq.) shall be credited to
- 7 the Nuclear Waste Fund as offsetting collections in amounts
- 8 not to exceed the amounts annually appropriated during
- 9 that period from the Nuclear Waste Fund. For fiscal year
- 10 2005, such amounts shall not exceed \$576,000,000. Con-
- 11 sistent with existing law, such amounts may only be used
- 12 for purposes authorized under the Nuclear Waste Policy Act
- 13 of 1982.
- 14 (b) Additional Necessary Sums.—To the extent
- 15 that the level of budgetary resources from offsetting collec-
- 16 tions is insufficient to implement activities under the Nu-
- 17 clear Waste Policy Act of 1982 for a fiscal year, there are
- 18 authorized to be appropriated for implementing those ac-
- 19 tivities such additional sums as may be necessary from the
- 20 balances in the Nuclear Waste Fund.
- 21 **SEC. 2. REPORT.**
- Not later than one year after the date of enactment
- 23 of this Act, and every two years thereafter, the Secretary
- 24 shall submit to the Congress a report on the adequacy of
- 25 the Nuclear Waste Fund that includes an assessment of
- 26 whether current unexpended balances in the Fund, if made

- 1 fully available to the Secretary, would affect annual fee de-
- 2 terminations (including whether a reduction to the fee may
- 3 be necessary) made pursuant to section 302(a)(4) of the Nu-
- 4 clear Waste Policy Act of 1982 (42 U.S.C. 10222(a)(4)).
- 5 The report shall also include recommendations to Congress
- 6 on whether this Act should be extended beyond its current
- 7 expiration date of September 30, 2009, and whether alter-
- 8 native approaches may be necessary to access unexpended
- 9 balances in the Nuclear Waste Fund.
