### A BILL

To reauthorize and amend the National Geologic Mapping Act of 1992.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Geologic
- 5 Mapping Reauthorization Act of 2004".

#### 1 SEC. 2. AMENDMENT REFERENCES.

2	Except as otherwise expressly provided, whenever in
3	this Act an amendment or repeal is expressed in terms
4	of an amendment to, or repeal of, a section or other provi-
5	sion, the reference shall be considered to be made to such
6	section or other provision of the National Geologic Map-
7	ping Act of 1992 (43 U.S.C. 31a et seq).
