Mr. FILNER introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend title 38, United States Code, to permit eligible veterans to receive direct access to chiropractic care.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Better Access to Chiro-
5 practors to Keep our Veterans Healthy (Back Our Vet-
6 erans Health) Act”.

1 **SEC. 2. EXPANDED CHIROPRACTOR SERVICES AVAILABLE**
2 **TO VETERANS.**

3 (a) MEDICAL SERVICES.—Paragraph (6) of section
4 1701 of title 38, United States Code, is amended by add-
5 ing at the end the following new subparagraph:

6 “(G) Chiropractic services.”.

7 (b) REHABILITATIVE SERVICES.—Paragraph (8) of
8 such section is amended by inserting “chiropractic,” after
9 “counseling,”.

10 (c) PREVENTIVE HEALTH SERVICES.—Paragraph
11 (9) of such section is amended—

12 (1) by redesignating subparagraphs (F)
13 through (K) as subparagraphs (G) through (L), re-
14 spectively; and

15 (2) by inserting after subparagraph (E) the fol-
16 lowing new subparagraph (F):

17 “(F) periodic and preventative chiropractic ex-
18 aminations and services;”.

19 **SEC. 3. DIRECT ACCESS FOR VETERANS TO CHIROPRACTIC**
20 **SERVICES.**

21 (a) IN GENERAL.—Chapter 17 of title 38, United
22 States Code, is amended by inserting after section 1710B
23 the following new section:

24 **“§ 1710C. Direct access to chiropractic services**

25 “(a) The Secretary shall permit eligible veterans to
26 receive needed medical services, rehabilitative services, and

1 preventative health services from a licensed doctor of
2 chiropractic on a direct access basis at the election of the
3 eligible veteran, if such services are within the State scope
4 of practice of such doctor of chiropractic.

5 “(b) The Secretary shall not discriminate among li-
6 censed health-care providers in the determination of need-
7 ed services.”.

8 (b) CLERICAL AMENDMENT.—The table of sections
9 at the beginning of such chapter is amended by inserting
10 after the item relating to section 1710B the following new
11 item:

“1710C. Direct access to chiropractic services.”.
