A BILL

To amend title 10, United States Code, to authorize the Secretary of Defense to accept the donation of frequent traveler miles, credits, and tickets for the purpose of facilitating the travel of members of the Armed Forces who are deployed away from their permanent duty station and are granted, during such deployment, rest and recuperative leave and certain other forms of leave and the travel of family members to be reunited with such a member, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Operation Hero Miles
- 3 Act of 2004".
- 4 SEC. 2. ACCEPTANCE OF FREQUENT TRAVELER MILES,
- 5 CREDITS, AND TICKETS TO FACILITATE THE
- 6 AIR OR SURFACE TRAVEL OF CERTAIN MEM-
- 7 BERS OF THE ARMED FORCES AND THEIR
- 8 FAMILIES.
- 9 Section 2608 of title 10, United States Code, is
- 10 amended—
- 11 (1) by redesignating subsections (g) through (k)
- as subsections (h) through (l), respectively; and
- 13 (2) by inserting after subsection (f) the fol-
- lowing new subsection:
- 15 "(g) OPERATION HERO MILES.—(1) The Secretary
- 16 of Defense may use the authority of subsection (a) to ac-
- 17 cept the donation of frequent traveler miles, credits, and
- 18 tickets for air or surface transportation issued by any air
- 19 carrier or surface carrier that serves the public and that
- 20 consents to such donation, and under such terms and con-
- 21 ditions as the air or surface carrier may specify. The Sec-
- 22 retary shall designate a single office in the Department
- 23 of Defense to carry out this subsection, including the es-
- 24 tablishment of such rules and procedures as may be nec-
- 25 essary to facilitate the acceptance of such frequent trav-
- 26 eler miles, credits, and tickets.

1	"(2) Frequent traveler miles, credits, and tickets ac-
2	cepted under this subsection shall be used only in accord-
3	ance with the rules established by the air carrier or surface
4	carrier that is source of the miles, credits, or tickets and
5	shall be used only for the purpose of—
6	"(A) facilitating the travel of a member of the
7	armed forces who—
8	"(i) is deployed on active duty away from
9	the permanent duty station of the member; and
10	"(ii) is granted, during such deployment,
11	rest and recuperative leave, emergency leave,
12	convalescent leave, or another form of leave au-
13	thorized for the member; or
14	"(B) facilitating the travel of family members
15	of the member to be reunited with the member.
16	"(3) The Secretary of Defense may enter into an
17	agreement with a nonprofit organization to use the serv-
18	ices of the organization—
19	"(A) to promote the donation of frequent trav-
20	eler miles, credits, and tickets under paragraph (1),
21	except that amounts appropriated to the Depart-
22	ment of Defense may not be expended for this pur-
23	pose; and

1	"(B) to assist in administering the collection
2	distribution, and use of donated frequent traveler
3	miles, credits, and tickets.
4	"(4) Members of the armed forces and family mem-
5	bers who receive air or surface transportation using fre
6	quent traveler miles, credits, or tickets donated under this
7	subsection are deemed to recognize no income from such
8	use. Donors of frequent traveler miles, credits, or tickets
9	under this subsection are deemed to obtain no tax benefit
10	from such donation.
11	"(5) In this subsection, the term 'family member' has
12	the meaning given that term in section 411h(b)(1) of title
13	37.".
