 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Fair Insurance Pre-
 - 5 miums for Disabled Veterans Act".

1	SEC. 2. REDUCTION IN SERVICE-DISABLED VETERANS IN-
2	SURANCE PREMIUMS.
3	(a) In General.—Section 1922(a) of title 38,
4	United States Code, is amended—
5	(1) by inserting " (1) " after " (a) "; and
6	(2) by striking the fourth sentence and all that
7	follows and inserting the following:
8	"(2) Insurance granted under this section shall be
9	issued upon the same terms and conditions as are con-
10	tained in the standard policies of National Service Life
11	Insurance, except that—
12	"(A) the premium rates for such insurance—
13	"(i) for premiums for months beginning
14	before the date of the enactment of the Fair In-
15	surance Premiums for Disabled Veterans Act
16	shall be based on the Commissioners 1941
17	Standard Ordinary Table of Mortality and in-
18	terest at the rate of $2\frac{1}{4}$ percent per year; and
19	"(ii) for premiums for months beginning
20	on or after that date shall be based upon the
21	2001 Commissioners Standard Ordinary Table
22	of Mortality and interest at the rate of 4.5 per-
23	cent per year;
24	"(B) all cash, loan, paid-up, and extended val-
25	ues—

1	"(i) for a policy issued under this section
2	before the date of the enactment of the Fair In-
3	surance Premiums for Disabled Veterans Act
4	shall be based upon the Commissioners 1941
5	Standard Ordinary Table of Mortality and in-
6	terest at the rate of $2\frac{1}{4}$ percent per year; and
7	"(ii) for a policy issued under this section
8	on or after that date shall be based upon the
9	2001 Commissioners Standard Ordinary Table
10	of Mortality and interest at the rate of 4.5 per-
11	cent per year;
12	"(C) all settlements on policies involving annu-
13	ities shall be calculated on the basis of the Annuity
14	Table for 1949, and interest at the rate of $2\frac{1}{4}$ per-
15	cent per year;
16	"(D) insurance granted under this section shall
17	be on a nonparticipating basis;
18	"(E) all premiums and other collections for in-
19	surance under this section shall be credited directly
20	to a revolving fund in the Treasury of the United
21	States; and
22	"(F) any payments on such insurance shall be
23	made directly from such fund

- 1 "(3) Appropriations to the fund referred to in sub-
- 2 paragraphs (E) and (F) of paragraph (2) are hereby au-
- 3 thorized.
- 4 "(4) As to insurance issued under this section, waiver
- 5 of premiums pursuant to section 602(n) of the National
- 6 Service Life Insurance Act of 1940 and section 1912 of
- 7 this title shall not be denied on the ground that the serv-
- 8 ice-connected disability became total before the effective
- 9 date of such insurance.
- 10 "(5) Administrative costs to the Government for the
- 11 costs of the program of insurance under this section shall
- 12 be paid from amounts credited to the fund under subpara-
- 13 graph (E) of paragraph (2), and payments for claims
- 14 against the fund for amounts in excess of amounts cred-
- 15 ited to the fund under that subparagraph (after such ad-
- 16 ministrative costs have been paid) shall be paid from ap-
- 17 propriations to the fund.".

- 21 SEC. 3. INCREASE IN MAXIMUM COVERAGE UNDER VET-
- 22 ERANS' MORTGAGE LIFE INSURANCE PRO-
- 23 **GRAM TO \$200,000.**
- 24 (a) Increase.—Subsection (b) of section 2106 of
- 25 title 38, United States Code, is amended—

1	(1) by inserting "(1)" after "(b)";
2	(2) by designating the second, third, and fourth
3	sentences as paragraphs (2), (3), and (4), respec-
4	tively;
5	(3) in paragraph (1), as designated by para-
6	graph (1) of this subsection, by striking "may not
7	exceed" and all that follows through "on the housing
8	unit." and inserting "shall be the amount of the
9	loan outstanding on the housing unit, except that—
10	"(A) coverage may not exceed \$200,000; and
11	"(B) a veteran may elect, in writing, to be cov-
12	ered for less than the maximum coverage available.";
13	and
14	(4) in paragraph (2), as designated by para-
15	graph (2) of this subsection, by striking "of such in-
16	surance" and inserting "of insurance provided a vet-
17	eran under this section".
18	(b) Conforming Amendment.—Subsection (g) of
19	such section is amended by striking "of this section or"
20	and inserting "or an election under that subsection or by".
21	(c) Effective Date.—The amendments made by
22	subsection (a) shall take effect at the end of the 120-day
23	period beginning on the date of the enactment of this Act.
