- 3 **SECTION 1. SHORT TITLE.**
- 4 This Act may be cited as the "Arizona Trail Feasi-
- 5 bility Study Act".

12	2004, and that consists of a corridor of open

15	"(ii) features deserts, canyons, moun-
16	tains, lakes, and rivers; and
17	"(iii) connects 6 wilderness areas, 4
18	national forests, 2 national parks, and 30
19	outdoor recreational areas.
20	"(B) REQUIREMENT.—The Secretary of
21	the Interior and the Secretary of Agriculture
22	shall jointly conduct the study under subpara-
