A BILL

To amend the Internal Revenue Code of 1986 to allow volunteer firefighters a deduction for personal safety clothing.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Volunteer Firefighter
- 5 Tax Relief Act of 2004".
- 6 SEC. 2. DEDUCTION FOR PERSONAL SAFETY CLOTHING OF
- 7 **VOLUNTEER FIREFIGHTERS.**
- 8 (a) IN GENERAL.—Part VII of subchapter B of chap-
- 9 ter 1 of the Internal Revenue Code of 1986 (relating to

- 1 additional itemized deductions for individuals) is amended
- 2 by redesignating section 223 as section 224 and by insert-
- 3 ing after section 222 the following new section:
- 4 "SEC. 223. PERSONAL SAFETY CLOTHING OF VOLUNTEER
- 5 FIREFIGHTERS.
- 6 "In the case of an individual who is a volunteer with
- 7 a volunteer fire department, there shall be allowed as a
- 8 deduction an amount equal to the amount paid during the
- 9 taxable year for personal safety clothing (including hel-
- 10 mets and boots) designed for use, and to be used by such
- 11 individual, in performing fire fighting services for such de-
- 12 partment."
- 13 (b) Deduction Allowed Whether or Not Tax-
- 14 PAYER ITEMIZES OTHER DEDUCTIONS.—Subsection (a)
- 15 of section 62 of such Code is amended by inserting after
- 16 paragraph (18) the following new paragraph:
- 17 "(19) Personal safety clothing of volun-
- 18 TEER FIREFIGHTERS.—The deduction allowed by
- 19 section 223.".
- 20 (c) Clerical Amendment.—The table of sections
- 21 for such part VII is amended by striking the last item
- 22 and inserting the following new item:

"Sec. 223. Personal safety clothing of volunteer firefighters."

- 1 (d) Effective Date.—The amendments made by
- 2 this section shall apply to taxable years beginning after

3 the date of the enactment of this Act.
