A BILL

To amend title 10, United States Code, to clarify requirements relating to predeployment and postdeployment medical exams of certain members of the Armed Forces.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Healthy Troops Act".

"(C) an assessment of mental health; 1 2 "(D) screening for diseases that are prevalent in members of the armed forces; and 3 "(E) referral to appropriate medical care for 4 5 any conditions needing further treatment. 6 "(3) A postdeployment medical examination shall consist of a self-administered survey followed by a clinical 8 examination conducted by medical personnel of the Department of Defense. The survey and clinical examina-9 10 tion— 11 shall include self-reported information 12 about any relevant exposures during the period of 13 deployment, including witnessing or participating in 14 combat and screening for post-traumatic stress dis-15 order; and "(B) shall be conducted when the member is re-16 17 deployed or otherwise leaves an area in which the 18 system is in operation (or as soon as possible there-19 after).". (b) STUDY.—The Secretary of Defense shall conduct 20 21 a study of the effectiveness of self-administered surveys 22 included in predeployment and postdeployment medical 23 exams of members of the Armed Forces that are carried out as part of the medical tracking system required under

- 1 section 1074f of title 10, United States Code (as amended
- 2 by subsection (a)).
