A BILL

To provide for continuing Federal reimbursement of emergency health services furnished to illegal aliens through foreign aid funds.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Country of Origin
- 5 Healthcare Accountability Act".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

- 1 (1) The Census Bureau estimates that some 8
 2 million illegal aliens reside in the United States, and
 3 health care treatment of illegal aliens imposes a sub4 stantial cost on medical providers and hospitals in
 5 numerous communities across America.
- 6 (2) American citizens should not be forced to
 7 pay for the treatment of illegal aliens, particularly
 8 when many Americans already struggle to pay their
 9 own medical expenses. Consequently, the cost of
 10 treatment of illegal aliens should be borne as a re11 duction in assistance provided to foreign countries.

12 SEC. 3. FEDERAL REIMBURSEMENT OF EMERGENCY

13 HEALTH SERVICES FURNISHED TO ILLEGAL

14 ALIENS THROUGH FOREIGN AID FUNDS.

- 15 (a) AVAILABILITY OF FUNDS.—Of the amounts ap16 propriated for any fiscal year (beginning with fiscal year
 17 2009) to carry out the provisions of sections 103, 105,
 18 106, and 131, and chapter 10 of part I of the Foreign
 19 Assistance Act of 1961, \$250,000,000 shall be available
 20 to the Secretary of Health and Human Services for the
 21 purpose of making allotments under the provisions re22 ferred to in subsection (b) for payments to eligible pro-
 - 2 ferred to in subsection (b) for payments to eligible pro-
- 23 viders in States. Funds made available under the previous
- 24 sentence for a fiscal year shall remain available until ex-
- 25 pended.

- 1 (b) Use of Funds.—The provisions of subsections
- 2 (b) through (e) of section 1011 of the Medicare Prescrip-
- 3 tion Drug, Improvement, and Modernization Act of 2003
- 4 (Public Law 108–173) shall apply to amounts made avail-
- 5 able for a fiscal year under subsection (a) in the same
- 6 manner as they apply to amounts appropriated for a fiscal
- 7 year under subsection (a) of such section.
