Mr. Renzi introduced the following bill; which was referred to the Committee on Resources

A BILL

- To direct the Secretary of the Interior and the Secretary of Agriculture to jointly conduct a study of certain land adjacent to the Walnut Canyon National Monument in the State of Arizona.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Walnut Canyon Study
 - 5 Act of 2004".
 - 6 SEC. 2. FINDINGS AND PURPOSE.
- 7 (a) FINDINGS.—Congress finds as follows:

- 1 (1) The Coconino National Forest was estab-2 lished in the State of Arizona on July 2, 1908.
- 3 (2) The Walnut Canyon National Monument in 4 the State of Arizona was originally designated as a 5 national monument by Presidential proclamation on 6 November 30, 1915, to protect Sinaguan cliff dwell-7 ings.
 - (3) Since the original designation, the Monument boundaries have been expanded to include 3,580 acres.
 - (4) National Forest System lands and State trust lands in the study area contain significant cultural and natural resources.
 - (5) The Coconino National Forest Land and Resources Management Plan of 1987 identified National Forest System land in the study area as land for nondevelopment or disposal under the National Forest Management Act of 1976 (16 U.S.C. 472a, et seq.).
 - (6) State trust land in the study area has been temporarily removed from consideration for development by State agencies with jurisdiction over the State trust land.
 - (7) The communities in the vicinity of the land in the study area support maintaining public uses of

1	the land surrounding the Monument while protecting
2	the resources of the land.
3	(8) Several interest groups have proposed ex-
4	panding the Monument and designating the ex-
5	panded area as a national park or national preserve
6	(9) The city of Flagstaff and Coconino County,
7	Arizona, have passed resolutions supporting further
8	review and study of, and the development of man-
9	agement options for the study area.
10	(10) To determine the appropriate management
11	of the adjacent land, interested parties have re-
12	quested a study to help identify management op-
13	tions.
14	(b) Purposes.—The purposes of this Act are—
15	(1) to authorize a study of the study area to
16	evaluate public uses and resource values; and
17	(2) to obtain recommendations for management
18	options for maintenance of the public uses and pro-
19	tection of resources of the study area.
20	SEC. 3. DEFINITIONS.
21	In this Act:
22	(1) Map.—The term "map" means the map en-
23	titled "Walnut Canyon Proposed Study Area" and

dated July 17, 2003.

1	(2) MONUMENT.—The term "Monument"
2	means the Walnut Canyon National Monument in
3	the State of Arizona.
4	(3) Secretaries.—The term "Secretaries"
5	means the Secretary of the Interior and the Sec-
6	retary of Agriculture, acting jointly.
7	(4) Study area.—The term "study area"
8	means the area identified on the map as "Walnut
9	Canyon Proposed Study Area", consisting of 30,818
10	acres, of which—
11	(A) 24,987 acres is Federal land in
12	Coconino National Forest;
13	(B) 2,037 acres is State land;
14	(C) 214 acres is private land; and
15	(D) 3,580 acres is the Monument.
16	SEC. 4. STUDY.
17	(a) In General.—The Secretaries shall conduct a
18	study of the study area.
19	(b) Requirements.—The study shall evaluate—
20	(1) the significance of the resources of the
21	study area as the resources pertain to—
22	(A) the management objectives of the For-
23	est Service; and
24	(B) the management objectives of the Na-
25	tional Park Service;

1	(2) the opportunities for maintaining existing
2	public uses such as grazing, hunting, and recreation;
3	and
4	(3) a range of options for managing and con-
5	serving resources by the National Park Service or
6	the Forest Service, or by both agencies acting joint-
7	ly, including the suitability and feasibility of—
8	(A) a boundary adjustment to the Monu-
9	ment;
10	(B) designation of the study area as a na-
11	tional park or preserve;
12	(C) maintaining the study area as man-
13	aged by the Forest Service; and
14	(D) any other designation or management
15	option that will accomplish both the protection
16	of resources and the maintenance of public use
17	and access for the study area.
18	(c) Consultation.—In conducting the study, the
19	Secretaries shall—
20	(1) contract with a third-party consultant with
21	experience in park and land use planning to prepare
22	a draft study; and
23	(2) collaborate with the persons identified in
24	subsection (d) in developing a scope of work for the

- draft study under the guidance of the third-party
- 2 consultant.
- 3 (d) REVIEW; RECOMMENDATIONS.—The Secretaries,
- 4 the Forest Supervisor of the Coconino National Forest,
- 5 the Superintendent of the Flagstaff Area National Monu-
- 6 ments, the Flagstaff City Council, and the Coconino Coun-
- 7 ty Board of Supervisors shall—
- 8 (1) review the draft study prepared by the
- 9 third-party consultant; and
- 10 (2) provide the third-party consultant com-
- 11 ments on and recommendations for the draft study.
- 12 (e) Report.—Not later than 18 months after the
- 13 date on which funding is made available to carry out this
- 14 Act, the Secretaries shall submit to Congress a report
- 15 that—
- 16 (1) describes the findings and conclusions of the
- 17 study conducted under this section, including the
- 18 recommendation of the persons identified in sub-
- section (d); and
- 20 (2) makes a recommendation for the future
- 21 management of the study area.
- 22 (f) Effect.—Nothing in this Act affects the man-
- 23 agement of the land depicted on the Map.
- 24 (g) Authorization of Appropriations.—

1	(1) In General.—There are authorized to be
2	appropriated such sums as are necessary to carry
3	out this Act.

(2) Effect.—Amounts made available under paragraph (1) shall not affect the amounts otherwise made available for Forest Service or National Park Service activities in the State of Arizona.
